RESOLUTION OF THE TRIBAL COUNCIL OF THE PYRAMID LAKE PAIUTE TRIBE NIXON, NEVADA

- WHEREAS, the Pyramid Lake Paiute Tribe is organized pursuant to the provisions of Section 16 of the Indian Reorganization Act (25 U.S.C. § 476) and is federally recognized by the United States Government through the Secretary of the Interior and the Bureau of Indian Affairs; and
- WHEREAS, the Pyramid Lake Paiute Tribe wishes to engage in contracts with the Bureau of Indian Affairs to provide critical services for the Tribe.
- WHEREAS, the Pyramid Lake Paiute Tribe would benefit from fiber to homes and businesses in Nixon and Sutcliffe.
- WHEREAS, the United States Department of Agriculture recently announced a second round funding opportunity for a USDA ReConnect Program.
- WHEREAS, this round of funding requires that 25% of total project costs be covered by the Tribe.
- WHEREAS, the Pyramid Lake Paiute Tribe submitted an application for first round funding in May, and as part of that application requested a waiver of \$879,574 in matching funds.
- **WHEREAS,** the State of Nevada created a Grant Matching Fund Program to provide match in rural and underserved communities.
- WHEREAS, the communities of Nixon and Sutcliffe meet the definition of rural and underserved.
- **WHEREAS,** it is anticipated that the State will begin making awards of Grant Matching Funds on a first come, first served basis in January.
- **WHEREAS,** the turnaround time for the State to make a decision on matching funds is expected to be 10 business days.
- WHEREAS, the deadline to submit a USDA ReConnect application is March 16, 2019.
- **THEREFORE BE IT RESOLVED** that the Pyramid Lake Paiute Tribe authorizes the submittal of an application to the State of Nevada, Department of Administration, Office of Grant Procurement, Coordination and Management requesting \$879,574 in match commitment be provided to a potential tribal application for USDA ReConnect Funds.
- **BE IT FURTHER RESOLVED** that staff will provide an update to Council once a decision is made by the State of Nevada.
- **BE IT FURTHER RESOLVED,** that a separate authorizing resolution will be required before a USDA ReConnect application can be submitted.
