RESOLUTION OF THE TRIBAL COUNCIL OF THE PYRAMID LAKE PAIUTE TRIBE NIXON, NEVADA

WHEREAS, the Pyramid Lake Paiute Tribe is organized pursuant to the provisions of Section 16 of the Indian Reorganization Act (25 U.S.C. § 476) and is federally recognized by the United States Government through the Secretary of the Interior and the Bureau of Indian Affairs; and

WHEREAS, there is a need to provide services to Victims of Crime on the Pyramid Lake Paiute Reservation.

WHEREAS, the Pyramid Lake Paiute Tribe Victims Services Department provides services to Victims of Crime.

WHEREAS, the State of Nevada, Division of Child and Family Services serves as a pass through entity for United States Department of Justice, Victims of Crime Funds.

WHEREAS, the Victims Services Department wishes to apply for a grant in the amount of \$51,135 to fund a Victim Advocate.

WHEREAS, the State of Nevada announced this grant opportunity on January 8, 2020.

WHEREAS, the deadline to submit applications is February 7, 2020.

WHEREAS, federally recognized Indian Tribes are not required to provide match on this.

WHEREAS, State of Nevada staff informed tribal staff that the State will honor the Tribe's Indirect Cost Rate if a letter referencing the Substantially Underserved Trust Area provisions of the Code of Federal Regulations is included.

WHEREAS, the Victims Services Department proposes to cover the Indirect Cost shortfall from their tribal funds budget for FY 2020.


THEREFORE BE IT RESOLVED that the Pyramid Lake Paiute Tribal Council authorizes the development of an application to the State of Nevada Division of Child and Family Services in the amount of \$51,135 for a Victims of Crime Assistance Grant.

BE IT FURTHER RESOLVED, that Staff is directed to prepare and the Chairman is authorized to sign a letter requesting the Tribe's full 19.6% Indirect Cost Rate to be included with the application.

BE IT FURTHER RESOLVED the Chairman of the Pyramid Lake Paiute Tribe is authorized to sign all documents needed to submit an application for a Victims of Crime Assistance Grant to the State of Nevada, Division of Child and Family Services.

CERTIFICATION
