RESOLUTION OF THE TRIBAL COUNCIL OF THE PYRAMID LAKE PAIUTE TRIBE NIXON, NEVADA

WHEREAS, the Pyramid Lake Paiute Tribe is organized pursuant to the provisions of Section 16 of the Indian Reorganization Act (25 U.S.C. § 476) and is federally recognized by the United States Government through the Secretary of the Interior and the Bureau of Indian Affairs; and

WHEREAS, the Pyramid Lake Paiute Tribal Council, governing body of the Pyramid Lake Paiute Tribe, pursuant to Article VI of the Constitution and By-Laws of the Tribe, is charged with the responsibility of establishing policy and taking action to provide administrative guidelines; and

WHEREAS, the Pyramid Lake Paiute Tribal Council created the Pyramid Lake Tax Commission to administer provisions of Title 2 – Tax Code and Administrative Code; and

WHEREAS, the Tax Commission has reviewed the Pyramid Lake Tribal Code, Title 2 – Taxation and is recommending a change as outlined below, with the recommended changes having been posted for public comment.

NOW, THEREFORE BE IT RESOLVED, that the Pyramid Lake Paiute Tribal Council hereby approves the recommendation of the Tax Commission and adopts the following amendment to the Pyramid Lake Tribal Code, Title 2 – Taxation: Chapter 209A

209A.002 Imposition and Amount of Tax on Wholesale Sales and Retail Sales: Distribution of Revenue Collected; Manner of Payment of costs of Commission; Regulations

(2) An excise tax is hereby imposed respecting wholesale sale of marijuana on tribal lands by a marijuana cultivation facility at the rate of 15% of the fair market value of the wholesale marijuana. The tax imposed pursuant to this section:


(a) Is the obligation of the marijuana cultivation facility and the marijuana cultivation facility shall not be entitled to the exemption accorder by § 220.002.

(c) The tax rate imposed by this subsection shall mirror the excise wholesale sale of marijuana imposed by the State of Nevada for sales within.

BE IT FINALLY RESOLVED, that the Pyramid Lake Paiute Tribal Council authorizes the Tribal Chairman or his designee to effectuate any and all administrative changes to implement this revision.

CERTIFICATION
