- WHEREAS, the Pyramid Lake Paiute Tribe recognizes the need to employ legal representatives to assist the Tribe in presenting or representing all of its legal needs; and
- WHEREAS, the Pyramid Lake Paiute Tribe desires to enter into a contract and sign letters of engagement with Quarles & Brady LLP, Attorneys at Law, to be the Pyramid Lake Paiute Tribe's Legal representation; and
- NOW, THEREFORE BE IT RESOLVED, that the Pyramid Lake Paiute Tribal Council hereby approves the contract with Quarles & Brady LLP, Attorneys at Law, attached hereto, and the Tribal General Counsel Attorney Contract shall cover the period from February 1st, 2020 and where this Contract may be terminated prior to June 30th 2021; and
