RESOLUTION OF THE TRIBAL COUNCIL OF THE PYRAMID LAKE PAIUTE TRIBE NIXON, NEVADA

WHEREAS, the Pyramid Lake Paiute Tribe is organized pursuant to the provisions of Section 16 of the Indian Reorganization Act (25 U.S.C. § 476) and is federally recognized by the United States Government through the Secretary of the Interior and the Bureau of Indian Affairs; and

WHEREAS, the Pyramid Lake Tribal Council, the governing body of the Pyramid Lake Paiute Tribe, realizes its duty and obligation to preserve and protect the welfare of its people as specified in the Constitution and By-laws of the Pyramid Lake Paiute Tribe; and

WHEREAS, the Pyramid Lake Tribal Council, pursuant to Article VI, Section 1 (m) of the Constitution and By-Laws of the Tribe, is charged with the responsibility of establishing policy and taking action to provide administrative guidelines; and

WHEREAS, the Pyramid Lake Tribal Council, having recognized the need for continuity of leadership for administration staff to implement the long-term strategic goals of the tribe;

WHEREAS, the Pyramid Lake Paiute Tribal Council approved through Resolution No PL 12-16 the formation of an Executive Team within the Administration staff consisting of the Executive Officer, the Programs Officer, the Business Officer, and the Comptroller;


WHEREAS, that the Executive Team shall have supervisory authority of all administration activities subordinate only to the Tribal Chairman

NOW, THEREFORE BE IT RESOLVED, that the Pyramid Lake Paiute Tribal Council hereby approves and adopts the attached Pyramid Lake Paiute Tribe Administrative Organizational Chart.

BE IT FINALLY RESOLVED, that this Pyramid Lake Paiute Tribe Administrative Organizational Chart supersedes and replaces any organizational chart previously approved by Pyramid Lake Paiute Tribal Council.

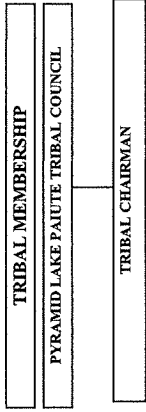
CERTIFICATION

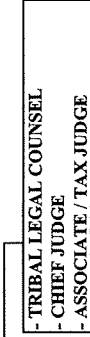

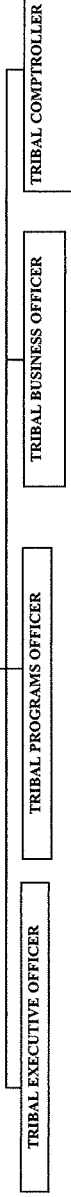
