RESOLUTION OF THE TRIBAL COUNCIL OF THE PYRAMID LAKE PAIUTE TRIBE NIXON, NEVADA

WHEREAS, the Pyramid Lake Paiute Tribe is organized pursuant to the provisions of Section 16 of the Indian Reorganization Act (25 U.S.C. § 476) and is federally recognized by the United States Government through the Secretary of the Interior and the Bureau of Indian Affairs; and

WHEREAS, the Pyramid Lake Paiute Tribe, pursuant to Article VI, Section 1 of the Constitution and By-laws of the Tribe,

WHEREAS, Washoe County formed a Hazard Mitigation Steering Committee with regional partners (the Cities of Sparks and Reno, the Reno-Sparks Indian Colony and the Pyramid Lake Paiute Tribe, the Truckee River Flood Management Project, and the North Lake Tahoe Fire Protection District, and the Truckee Meadows Fire Protection District) and the efforts of this committee have resulted in the 2020 Regional Hazard Mitigation Plan; and

WHEREAS, the Pyramid Lake Paiute Tribe in cooperation with Washoe County and other regional partners conducted a Hazard Vulnerability Analysis (HVA) and integrated public input as part of this process, to consider the natural, technological, and human caused risks to which the region is vulnerable; and

WHEREAS, recent events have shown that the Pyramid Lake Paiute Tribe must remain ever vigilant to eliminate or reduce the risk to human life, property and the environment posed by hazards; and


WHEREAS, the Regional Hazard Mitigation Plan's purpose is to integrate hazard mitigation strategies into the activities and programs of the Pyramid Lake Paiute Tribe; and

WHEREAS, The Regional Hazard Mitigation Plan will continue to be revised as new developments occur.

NOW, THEREFORE BE IT RESOLVED, that the Pyramid Lake Paiute Tribal Council hereby approves on behalf of the residents of the Pyramid lake Paiute Tribe, adopt the Washoe County Regional Hazard Mitigation Plan, and further direct that the PLFR/EMS continue to inform the public and community of the hazard mitigation strategies recommended by the plan.

CERTIFICATION

It is hereby certified that the foregoing resolution of the Pyramid Lake Paiute Tribal Council, governing body of the Pyramid Lake Paiute Tribe, composed of ten members, of whom ten (10) constituting a quorum were present at a meeting duly held on the 20th day of March, 2020 was adopted by the affirmative vote of nine (9) FOR and zero (0) AGAINST, with zero (0) ABSTENTIONS; pursuant to the authority contained in the Constitution and By-laws of the Pyramid Lake Paiute Tribe.
