RESOLUTION OF THE TRIBAL COUNCIL OF THE PYRAMID LAKE PAIUTE TRIBE NIXON, NEVADA

- WHEREAS, the Pyramid Lake Paiute Tribe is organized pursuant to the provisions of Section 16 of the Indian Reorganization Act (25 U.S.C. § 476) and is federally recognized by the United States Government through the Secretary of the Interior and the Bureau of Indian Affairs; and
- **WHEREAS**, the Pyramid Lake Paiute Tribe declared a State of Emergency due to the COVID-19 outbreak of 2020.
- WHEREAS, the CARES Act made an appropriation for the EMPG-Supplemental Program to assist local and tribal Fire and EMS Departments with increased costs associated with the COVID-19 pandemic.
- WHEREAS, the Pyramid Lake Paiute Fire and EMS Department has incurred overtime costs associated with the COVID-19 Pandemic
- **WHEREAS,** the EMPG-Supplemental Notice of Funding Opportunity allows for overtime costs to be paid with EMPG funds.
- WHEREAS, there is a 50% Match Requirement on this grant.
- WHEREAS, in-kind match is allowable on this project. .
- WHEREAS, per pages 9 and 11 of the Notice of Funding Opportunity, full indirect costs can be paid so long as the grantee provides a copy of its negotiated Indirect Cost Rate.
- **WHEREAS,** the US Department of Homeland Security allocated funds to the State of Nevada, Division of Emergency Management to subgrant to local and tribal governments.

THEREFORE BE IT RESOLVED that the Pyramid Lake Tribal Council Authorizes an application to the State of Nevada, Division of Emergency Management in the amount of \$12,050 and authorizes the Chairman to sign all documents needed to file the application.

BE IT FURTHER RESOLVED that the Pyramid Lake Paiute Tribal Council authorizes and commits \$12,050 in-kind match (specifically the time and overtime of Paramedics, Emergency Medical Technicians, and Advanced Emergency Medical Technicians) be dedicated to this project.
