RESOLUTION OF THE TRIBAL COUNCIL OF THE PYRAMID LAKE PAIUTE TRIBE NIXON, NEVADA

WHEREAS, the Pyramid Lake Paiute Tribe, is organized pursuant to the provisions of Section 16 of the Indian Reorganization Act, (25 U.S.C. 476) and is Federally recognized by the United States Government through the Secretary of the Interior and bureau of Indian Affairs; and

WHEREAS, the Pyramid Lake Paiute Tribe, currently receives annual funding (Tribal Shares) under the Tribal Transportation Program (TTP) for tribal Transportation projects; and

WHEREAS, 2% planning funds and construction funds in the Tribal Shares can be used to fund Tribal Transportation Planning Projects; and

WHEREAS, The Pyramid Lake Paiute Tribe has an existing Tribal Transportation Improvement Program (TTIP), which identifies previously approved projects, for the five-year period beginning year 2019 and ending year 2023; and


WHEREAS, The Pyramid Lake Paiute Tribe has officially closed all lake activity to outside visitors to Pyramid Lake, located on the Pyramid Lake Paiute Reservation to prevent the spread of the Covid 19 virus in our communities; and

WHEREAS, the Pyramid Lake Paiute Tribe desires to update our current Tribal Transportation Improvement Program (TTIP) with the addition of the Covid 19 Road Closure Project closing State Route 445 and State Route 446 to all non-tribal and non-residential traffic to Pyramid Lake.

NOW, THEREFORE, BE IT RESOLVED that the Pyramid Lake Paiute Tribal Council hereby approves, supports, and authorizes the submittal of the request to BIA Transportation to add the Covid 19 Road Closure Project to the updated TTIP for the five-year period beginning in FY 2020 to FY 2024 as identified in the Tribal Transportation Program TTIP fiscal year 2020-2024 spreadsheet, hereby attached to this resolution.

CERTIFICATION
