**RESOLUTION NO.: PL 059-20** 

## RESOLUTION OF THE TRIBAL COUNCIL OF THE PYRAMID LAKE PAIUTE TRIBE NIXON, NEVADA

WHEREAS, the Pyramid Lake Paiute Tribe is organized pursuant to the provisions of Section 16 of the Indian Reorganization Act (25 U.S.C. § 476) and is federally recognized by the United States Government through the Secretary of the Interior and the Bureau of Indian Affairs; and

WHEREAS, pursuant to the Pyramid Lake Paiute Tribe Constitution, Art. VI, Sec. 1(f), the Tribal Council has the authority to "administer any funds or property within the control of the tribe, to make expenditures from available funds for public purposes, including salaries or other remuneration of tribal officials or employees, such salaries or remuneration to be paid only for services actually authorized in a regular and legal manner and actually rendered"; and

WHEREAS, pursuant to the Pyramid Lake Paiute Tribe Constitution, Art. VI, Sec. 1(f) all such "expenditures shall be by resolution duly approved by a majority vote of the council, and the amounts so expended shall be a matter of public record at all times"; and

WHEREAS, pursuant to the Pyramid Lake Paiute Tribe Constitution, Art. VI., Sec. 1(m) the Tribal Council has the authority to "adopt resolutions regulating the procedure of the council itself and of other tribal agencies and tribal officials of the reservation"; and

**WHEREAS**, pursuant to the Pyramid Lake Paiute Tribe By-Laws, Art. VII, Sec. 1, the Tribal Council has the authority to determine just cause for aid and assistance to tribal members; and

**WHEREAS**, pursuant to the Pyramid Lake Paiute Tribe By-Laws, Art. VII, Sec. 2, the Tribal Council has the authority and responsibility to promote the education of the Tribe's children; and

**WHEREAS,** on December 19, 2019, a novel coronavirus now known as COVID-19 was first detected in China and has now spread globally; and

**WHEREAS**, on March 12, 2020, Governor Steve Sisolak by Executive Order issued a Declaration of Emergency for the State of Nevada; and

**WHEREAS,** on March 13, 2020, the President of the United States declared a national emergency regarding the COVID-19 virus pursuant to Sec. 501(6) of the Robert T.

Stafford Disaster Relief and Emergency Assistance Act, 42 U.S.C. 5121-5207 (the "Stafford Act"); and

WHEREAS, on March 16, 2020, Chairman Anthony Sampson, pursuant to Tribal Council Resolution No. PL 37-16, declared a tribal emergency concerning the COVID-19 pandemic; and

WHEREAS, on March 16, 2020, Governor Sisolak ordered the closure of all kindergarten through Grade 12 schools, including the public schools on the Reservation, and since then County School Districts have undertaken emergency efforts to offer distance learning to their pupils, which is now the only method available to educate the Tribe's children during this time; and

WHEREAS, on March 17, 2020, the Tribal Council passed Resolution No. C03-66-20 which declared a tribal emergency concerning the COVID-19 pandemic; and

**WHEREAS,** on March 18<sup>th</sup>, 2020, the Chairman closed the Tribe's public services, such as the community center, the senior center, the museum, and childcare centers; and

WHEREAS, on March 20<sup>th</sup>, 2020, the Tribal Council ordered the closure of Pyramid Lake and public access to Pyramid Lake for permitted recreational activities; and

**WHEREAS**, as of the date of this Resolution, the Pyramid Lake Paiute Tribe has 25 total positive confirmed cases, 3 hospitalizations, 0 deaths, and 22 active, and 141 tests performed, 104 tests negative, and 12 results pending for COVID-19; and

**WHEREAS**, on April 27<sup>th</sup>, 2020, the Tribal Council passed by motion an effective date of May 4<sup>th</sup>, 2020 to furlough at least 36 tribal government employees; and

WHEREAS, the closure of schools and certain public services and loss of employment or reduced wages have resulted in unexpected increase in costs, loss of income and other burdens for the Tribe's members and families living both on and off the reservation; and

WHEREAS, on March 27, 2020, President Trump signed into law the Coronavirus Aid, Relief, and Economic Security (CARES Act), which responded to the COVID-19 public health emergency and its impact on the economy, public health, state and local governments, individuals, and businesses; and

WHEREAS, Title V of the CARES Act authorized the Coronavirus Relief Fund (CRF) for payments to state, local, and tribal governments for increased expenditures and costs related to the COVID-19 public health emergency; and

WHEREAS, the CARES Act authorizes the Tribe to use CRF funds for "necessary expenditures" incurred between March 1, 2020 and December 30, 2020 that are directly related to the COVID-19 public health emergency and that are "not accounted for" in the Tribe's Fiscal Year 2020 approved budget; and

WHEREAS, on April 22, 2020 the Department of Treasury, which administers the CRF, issued guidance describing the types of "necessary expenditures" that governments might incur that could be funded from the CRF; and

WHEREAS, according to the Treasury Guidance, the CRF may be used to provide income support to individuals and families who are facing economic hardship, including loss of income, or require assistance with mortgage payments, rent payments, utilities payments, food, medicine, and to alleviate other financial hardships due to the COVID-19 public health emergency; and

**WHEREAS**, on May 7<sup>th</sup>, 2020 the Tribe received an initial distribution of \$14,829,367.44 from the CRF to cover "necessary expenditures" related to the COVID-19 public health emergency; and

WHEREAS, on May 15, 2020 through Resolution No.: PL 058-20, the Tribal Council approved programs and budget to utilize the Tribe's CRF distribution to cover costs for the tribal government and tribal enterprises and economic impacts to tribal employees and tribal members, related to the COVID-19 public health emergency and consistent with the CARES Act and the Treasury Guidance; and

WHEREAS, the Tribal Council has developed the attached Coronavirus Relief Fund General Welfare Grant Program for Tribal Members, to promote the general welfare of the Tribe and its members by: alleviating the financial hardships endured from loss of income and increased costs; providing financial assistance with mortgage, rental, and utility payments; ensuring food security and continued education; providing assistance for medical and health services; and providing unreimbursed reasonable and necessary personal, living, and family expenses incurred due to the COVID-19 disaster and public health emergency situation; and

WHEREAS, the Tribal Council finds it in the best interest of the Tribe and its members to approve the attached Coronavirus Relief Fund General Welfare Grant Program for eligible Tribal Members.

**NOW THEREFORE BE IT RESOLVED** that the Pyramid Lake Paiute Tribal Council approves the attached Coronavirus Relief Fund General Welfare Grant Program for eligible Tribal Members; and

**BE IT FURTHER RESOLVED,** that the Pyramid Lake Paiute Tribal Council reserves the authority to approve, by future resolution, any amendments to the CRF General Welfare Grant Program; and

**BE IT FINALLY RESOLVED**, that the Pyramid Lake Paiute Tribal Council authorizes the Chairman to sign all documents and take any necessary and proper action to carry out the intent of this Resolution.

## CERTIFICATION

It is hereby certified that the foregoing resolution of the Pyramid Lake Paiute Tribal Council, governing body of the Pyramid Lake Paiute Tribe, composed of ten members, of whom <u>nine (9)</u> constituting a quorum were present at a meeting duly held on the <u>15<sup>th</sup></u> day of <u>May 2020</u> was adopted by the affirmative vote of <u>six (6)</u> FOR and <u>one (1)</u> AGAINST, with <u>one (1)</u> ABSTENTION; pursuant to the authority contained in the Constitution and By-laws of the Pyramid Lake Paiute Tribe.
