RESOLUTION OF THE TRIBAL COUNCIL OF THE PYRAMID LAKE PAIUTE TRIBE NIXON, NEVADA

- WHEREAS, the Pyramid Lake Paiute Tribe is organized pursuant to the provisions of Section 16 of the Indian Reorganization Act (25 U.S.C. Section § 476) and is federally recognized by the United States Government through the Secretary of the Interior and the Bureau of Indian Affairs; and
- WHEREAS, The Pyramid Lake Paiute Tribe has identified a need to construct a paved road bypassing the community of Wadsworth, Nevada to enhance safety and provide long term economic development; and
- WHEREAS, The Pyramid Lake Paiute Tribe has identified the Wadsworth Bypass Road as the number one Tribal Transportation Priority as identified on resolution PL 19-16 dated March 18, 2016 and;
- **WHEREAS,** The Tribe has been burdened with COVID-19 issues that severely impeded our regular schedule for grants application and;
- **WHEREAS**, The Tribe desires to apply for the 2020 BUILD grant using the 2019 documents which remain applicable and restated as following; and continuing
- WHEREAS, The Tribe's engineering consultant has estimated the total cost to construct the Wadsworth Bypass Road is \$8,888,100.00 and;
- WHEREAS, The Department of Transportation, Federal Highway Administration has solicited grant applications for Better Utilizing Investments to Leverage Development or "BUILD" Grants for FY 2020; and
- **WHEREAS,** The Tribe desires \$6,221,670.00 of the construction cost to be funded by a Better Utilizing Investments to Leverage Development or "BUILD" grant and;
- **WHEREAS,** The Tribe desires \$2,666,430.00 of existing Pyramid Lake Tribal Transportation funds reserved for the construction of Wadsworth Bypass Road to be used as a match as required and to improve our opportunity of receiving the "BUILD" grant;
- **NOW, THEREFORE BE IT RESOLVED**, that the Pyramid Lake Paiute Tribal Council hereby authorizes the Chairman or his designee to submit a Better Utilizing Investments to Leverage Development or "BUILD" grant application in the amount of \$6,221,670.00 to the

Federal Highway Administration for the construction of Wadsworth Bypass Road as previously approved in Tribal Resolution PL 038-19; and

THEREFORE BE IT FURTHER RESOLVED, that the Pyramid Lake Paiute Tribal Council hereby authorizes \$2,666,430.00 of existing Pyramid Lake Tribal Transportation funds to be used as a match for the "BUILD" grant, Wadsworth Bypass Road Construction and;

BE IT FINALLY RESOLVED that the Tribal Chairman or his designee be authorized to negotiate, extend or amend this grant application as needed.
