## RESOLUTION OF THE TRIBAL COUNCIL OF THE PYRAMID LAKE PAIUTE TRIBE NIXON, NEVADA

- WHEREAS, the Pyramid Lake Paiute Tribe is organized pursuant to the provisions of Section 16 of the Indian Reorganization Act (25 U.S.C. § 476) and is federally recognized by the United States Government through the Secretary of the Interior and the Bureau of Indian Affairs (BIA); and
- WHEREAS, the Pyramid Lake Paiute Tribe (Tribe) issued Tribal land assignments to eligible Tribal members for purposes of agricultural use consistent with the BIA intention to establish Tribal agricultural operations for Pyramid Lake Tribal members; and
- **WHEREAS**, the Tribe determines the continual need for federal funding to support the service, repair, and replacement of irrigation structures within the Tribal irrigation systems on the Pyramid Lake Paiute Reservation; and
- WHEREAS, the Tribe has confirmed there are serious service, repair, and replacement of irrigation structures throughout the Tribal irrigation delivery system aimed to increase the efficiency for irrigation deliveries to Tribal land assignments for agricultural purposes and to provide safety for the use of the irrigation structures; and
- WHEREAS, the BIA Western Region Office (WRO) notified the Tribe that Water Infrastructure Improvement for the Nation (WIIN) Act funding is available through a Public Law 93-638 contract to provide funding support for the irrigation service, repair, and replacement of irrigation structures within the Tribal irrigation delivery systems; and
- WHEREAS, the Tribe is interested with obtaining the WIIN Act funding and urges the BIA to issue the PL 93-638 contract funding to serve the purpose of the service, repair, and replacement of irrigation structures throughout the Tribal irrigation delivery systems; and
- NOW, THEREFORE, BE IT RESOLVED, that the Pyramid Lake Paiute Tribal Council the governing body for the Pyramid Lake Paiute Tribe approves the application to

request the WIIN Act funding from the BIA WRO as described in a PL 93-638

**BE IT FINALLY RESOLVED,** that the Tribal Chairman or his designee is authorized to formalize and execute said contract with the Bureau of Indian Affairs Western Regional Office.
