RESOLUTION OF THE TRIBAL COUNCIL OF THE PYRAMID LAKE PAIUTE TRIBE NIXON, NEVADA

WHEREAS, the Pyramid Lake Paiute Tribe, is organized pursuant to the provisions of Section 16 of the Indian Reorganization Act, (25 U.S.C. § 476) and is Federally recognized by the United States Government through the Secretary of the Interior and the Bureau of Indian Affairs; and

WHEREAS, the Pyramid Lake Paiute Tribal Council has delegated the authority to the Pyramid Lake Fisheries to be responsible for the operation of all aspects of the Pyramid Lake Tribal Fisheries; and

WHEREAS, Pyramid Lake Fisheries has the primarily responsibility of monitoring Pyramid Lake to ensure Water Quality, and has a goal to maintain both a recreational and trophy fishery for Lahontan Cutthroat Trout, while working collaboratively with partners to protect, conserve, and restore aquatic resources, fish habitats, and water quality in Pyramid Lake and the Lower Truckee River; and

WHEREAS, Pyramid Lake and the Truckee River are important LCT recreational sport/trophy fisheries in Nevada, both of which should be preserved, protected, and enhanced; and


WHEREAS, the Pyramid Lake Fisheries requests \$46,792.00 from the Pyramid Lake License Plate Fund to purchase a RBR Maestro instrument for the purpose of monitoring Pyramid Lake to ensure Water Quality Standards are being achieved to protect the Tribe's beneficial uses like aquatic life in Pyramid Lake; and

NOW, THEREFORE, BE IT RESOLVED, that the Pyramid Lake Paiute Tribal council hereby approves Pyramid Lake Fisheries requests of \$46,792.00 from the Pyramid Lake License Plate Fund to purchase a RBR Maestro instrument to monitor Pyramid Lake Water Quality.

CERTIFICATION

It is hereby certified that the foregoing resolution of the Pyramid Lake Tribal Council, governing body of the Pyramid Lake Paiute Tribe, composed of ten members, of whom ***ten (10)*** constituting a quorum were present at a meeting duly held on the ***21st*** day of ***July 2021***, was adopted by the
