## RESOLUTION OF THE TRIBAL COUNCIL OF THE PYRAMID LAKE PAIUTE TRIBE NIXON, NEVADA

- WHEREAS, the Pyramid Lake Paiute Tribe is organized pursuant to the provisions of Section 16 of the Indian Reorganization Act (25 U.S.C. § 476) and is federally recognized by the United States Government through the Secretary of the Interior and the Bureau of Indian Affairs; and
- WHEREAS, the Pyramid Lake Paiute Tribe, in order to preserve and protect the health and general welfare of the Tribe pursuant to Article VI, Section 1 of the Constitution and By-laws of the Tribe, herby recognizes the importance of formally applying for and accepting a grant from the Nevada Department of Heath and Human Services, Division of Public and Behavioral Health (EMS). For the Pyramid Lake Fire Rescue/EMS to teach a state certified course for certification as an Emergency Medical Technician (EMT). This grant is to provide the necessary supplies and materials as well as instructor costs for the PLFR/EMS, in order train members of the community and surrounding areas to become State Certified EMT's as part of the PLFR/EMS program; and
- WHEREAS, the PLFR/EMS in conjunction with the finance department shall be charged with maintaining proper reporting for the duration of the grant and report as needed to the Tribal Council. The grant has no matching funds and the grant includes the current IDC rate of 24.55%. the PLFR/EMS shall follow Tribal policies as well as specific departmental policies under the direction of the Emergency Response Coordinator and the Tribal Council; and
- **NOW, THEREFORE BE IT RESOLVED,** that the Pyramid Lake Paiute Tribal Council hereby approves the application and acceptance of the EMT training grant.
- **BE IT FINALLY RESOLVED,** the Pyramid Lake Paiute Tribal Council herby authorizes the Pyramid Lake Tribal Chairwoman and/or her designee to effectuate any and all administrative actions necessary to carry out the intent of this Resolution.
