NATIONAL TRIBAL TRANSPORTATION FACILITIES INVENTORY UPDATE 2022-PYRAMID LAKE PAIUTE TRIBE

The NTTFI refers to public roads that are located within or provides access to an Indian Reservation or Indian trust lands. The Pyramid Lake Transportation Planning office is asked to update our Indian Roads Inventory on a yearly basis and evaluate what needs to be added, changed or deleted from our list of roadways on the reservation.

The Transportation Planning office and Roads Maintenance Department are funded through the BIA based on the number of roads and types of maintenance associates with the transportation routes listed on the National Tribal Transportation Inventory.

During this process we generally engage with the public through public meeting venues to get feedback on roads maintenance and adding or deleting roads in each community.

There are several roads and multi-use walking paths that we would like to add as well as some new access roads and boat docks on Pyramid Lake.

Here is our proposed list so far:

- Pelican boat ramp pavement
- Extension of Sutcliffe loop road w/boat dock (Marina Beach)
- · Sutcliffe community building parking lot and paved road
- Extension of hard scrabble creek road to the ranch
- Sutcliffe community multi-use walking paths (Pawkwe, Tufa Rock, Desert Flower, Jigger Bob)
- Wadsworth multi-use walking paths 4-8th street and surrounding community
- Extension of Wadsworth Cemetery with road upgrades
- Brady Hill Neighborhood multi use walking paths
- Extension of Church Street with addition of more land for cemetery plots
- Basin Road to Pyramid Lake High School multi-use walking path
- Basin Road community multi-use walking paths (Basin and new housing area)
