## **RESOLUTION OF THE TRIBAL COUNCIL OF THE PYRAMID LAKE PAIUTE TRIBE NIXON, NEVADA**

**WHEREAS,** the Pyramid Lake Paiute Tribe is organized pursuant to the provisions of Section 16 of the Indian Reorganization Act (25 U.S.C. § 476) and is federally recognized by the United States Government through the Secretary of the Interior and the Bureau of Indian Affairs; and

**WHEREAS,** the Pyramid Lake Paiute Tribe, pursuant to Article VI, Section 1 of the Constitution and By-laws of the Tribe, is authorized to manage its own accounts and funds; and

**WHEREAS,** the Pyramid Lake Paiute Tribe has bank accounts with Wells Fargo; and

**WHEREAS,** Wells Fargo has requested Pyramid Lake Paiute Tribe Tribal Council to provide a Tribal Resolution specifying the individuals authorized to sign on behalf of the Tribe with respect to the Tribe's Wells Fargo checking accounts; and


