RESOLUTION OF THE TRIBAL COUNCIL OF THE PYRAMID LAKE PAIUTE TRIBE NIXON, NEV ADA

WHEREAS, the Pyramid Lake Paiute Tribe is organized pursuant to the provisions of Section 16 of the Indian Reorganization Act (25 U.S.C. § 476) and is federally recognized by the United States Government through the Secretary of the Interior and the Bureau of Indian Affairs; and

WHEREAS, the Pyramid Lake Paiute Tribe, pursuant to Article VI, Section 1 of the Constitution and By-laws of the Tribe,

WHEREAS, This organization is an Indian Organization known as the Pyramid Lake Paiute Tribe of Nevada defined under the Indian Reorganization Act of June 18, 1934, as amended, to exercise certain rights of home rule and to be responsible for the promotion of cultural, economic and social welfare of its tribal members; and

WHEREAS, the Pyramid Lake Paiute Tribe of Nevada is federally recognized by the United States Government and the Secretary of the Interior as a Native American Tribe, and by the power vested in the Tribal Constitution and Bylaws the Council has the authority to enter into contracts and administer any funds with the control of the Tribe; and

WHEREAS, the Pyramid Lake Paiute Tribe of Nevada in collaboration with the Board of Regents, Nevada System of Higher Education on behalf of the University of Nevada, Reno and Nevada Cooperative Extension enters into an agreement to apply for funding to implement the Federally Recognized Tribes Extension Program (FRTEP) on the Pyramid Lake Reservation; and

WHEREAS, the short-term goals of the FRTEP program are to provide education to reservation farmers and ranchers through educational workshops, field days, and one-on-one mentorship for food security and food safety; implement a 4-H youth development and youth nutrition program, utilizing traditional foods, on the reservation; collaborate with the Pyramid Lake Paiute Tribe on access to USDA programs, irrigation management, and exploring the possibilities of alternative crops; provide assistance on tribal economic development planning for future ranching and livestock activities; and


NOW, THEREFORE BE IT RESOLVED THAT, the Pyramid Lake Paiute Tribal Council approves the collaboration and funding agreements between the Boards of Regents, Nevada System of Higher Education to apply for funding realizing any party may terminate any agreements within 30 days' notice and continuation of this program is contingent upon funding; and

BE IT FURTHER RESOLVED THAT, that if funding is received to implement the FRTEP program on the Pyramid Lake Reservation, the Pyramid Lake Paiute Tribe will provide office space on the reservation for the FRTEP agent and will provide input into the overall direction of the program; and

BE IT FINALLY RESOLVED THAT, that the chairman, or designee in absence of the chairman, is hereby authorized to negotiate, collaborate and take any actions necessary to execute the intentions of this Resolution.

CERTIFICATION

It is hereby certified that the foregoing resolution of the Pyramid Lake Paiute Tribal Council, governing body of the Pyramid Lake Paiute Tribe, composed of ten members, of whom ten (10) constituting a quorum were present at a meeting duly held on the 21st day of January 2022, was adopted by the affirmative vote of nine (9) FOR and zero (0) AGAINST, with zero (0) ABSTENTIONS; pursuant to the authority contained in the Constitution and By-laws of the Pyramid Lake Paiute Tribe.
