- WHEREAS, certain aspects of the Department of Health & Human Services (DHHS) Child Care Development Funds (CCDF) FY21 American Rescue Plan Act (ARPA) funding are to be used for funding. To purchase Teaching Strategies for Early Childhood within the Tribal Child Care Centers, the Chastain Consulting Services, LLC meets this criteria for mental health consulting and social and emotional wellness curriculum. The request for the Chastain Consulting Services with the Tribal Child Care Centers will be budgeted at \$71,250.00.
- **NOW, THEREFORE BE IT RESOLVED,** that the Pyramid Lake Paiute Tribal Council hereby approves the proposed Department of Health & Human Services FY21 American Rescue Plan Act budget to be used in the delivery of the Chastain Consulting Services, LLC.
- **BE IT FINALLY RESOLVED,** the Pyramid Lake Paiute Tribal Council adopts, approves and supports the attached quote from Chastain Consulting Services, LLC to mitigate and prevent the spread of COVID 19.
