RESOLUTION OF THE TRIBAL COUNCIL OF THE PYRAMID LAKE PAIUTE TRIBE NIXON, NEVADA

- WHEREAS, the Pyramid Lake Paiute Tribe is organized pursuant to the provisions of Section 16 of the Indian Reorganization Act (25 U.S.C. § 476) and is federally recognized by the United States Government through the Secretary of the Interior and the Bureau of Indian Affairs; and
- WHEREAS, the Pyramid Lake Paiute Tribe, pursuant to Article VI, Section 1 of the Constitution and By-laws of the Tribe, and
- WHEREAS, the Pyramid Lake Paiute Tribe recognizes the importance of providing protection for the quality of the environment for the Pyramid Lake Paiute Reservation's natural resources and for its communities; and
- WHEREAS, the United States Environmental Protection Agency (EPA) has issued a Notice of Funding Opportunity for funds under the 128(a) Tribal Response Program Grant; and
- WHEREAS, the Pyramid Lake Tribal Response Program ensures that timely survey and inventory of brownfields sites in order to protect human health and the environment; and
- **WHEREAS**, additional oversight and enforcement authorities to ensure that response actions are developed in the Pyramid Lake Natural Resources Department; and
- **WHEREAS**, the Pyramid Lake Tribal Response Program ensures assistance in remediating and redeveloping brownfields sites throughout the Pyramid Lake Reservation; and
- WHEREAS, the application is due on April 18th, 2022; and
- NOW, THEREFORE BE IT RESOLVED, that the Pyramid Lake Paiute Tribal Council hereby approves the Pyramid Lake Paiute Triba Fiscal Year 2023 EPA 128(A) Tribal Response Program grant application.
- **BE IT FINALLY RESOLVED,** that the Tribal Chairperson or designee is authorized to execute the application process with the EPA Region 9.
