RESOLUTION OF THE TRIBAL COUNCIL OF THE PYRAMID LAKE PAIUTE TRIBE NIXON, NEVADA

WHEREAS,

the Pyramid Lake Paiute Tribe, is organized pursuant to the provisions of Section 16 of the Indian Reorganization Act, (25 U.S.C. § 476) and is Federally recognized by the United States Government through the Secretary of the Interior to negotiate with the U.S. Department of the Interior and the Bureau of Indian Affairs; and

WHEREAS,

the Pyramid Lake Paiute Tribal Council is the duly-elected governing body of the Pyramid Lake Paiute Tribe, responsible for enacting laws and regulations, and the planning and implementation of policy that directly affects the environment, specifically Water Quality, within the exterior boundaries of the Pyramid Lake Indian Reservation (PLIR); and,

WHEREAS,

the Wetland Program will provide protection for the physical, chemical, and biological integrity of water bodies within the PLIR, and will provide the ability to regulate habitat protection for plant and wildlife species dependent upon the Truckee River and Pyramid Lake water resources; and,

WHEREAS,

the Pyramid Lake Paiute Tribe's Clean Water Act (CWA) Performance Partnership Grant includes a combination of CWA Section 106, CWA Section 319 Base and Competitive, CWA Section 104 and CWA Section 106 Multipurpose grants.

NOW, THEREFORE, BE IT RESOLVED, that the Pyramid Lake Paiute Tribal council hereby approves, supports, and authorizes the submittal of the Fiscal Year 2023 CWA 104(b)(c) Grant to the U.S. Environmental Protection Agency (EPA).

BE IT FURTHER RESOLVED, that the Tribal Chairwoman or designee by hereby authorized to negotiate and sign all grant awards and other future administrative documents necessary for project award and implementation.
