RESOLUTION OF THE TRIBAL COUNCIL OF THE PYRAMID LAKE PAIUTE TRIBE NIXON, NEVADA

- WHEREAS, the Pyramid Lake Paiute Tribe is organized pursuant to the provisions of Section 16 of the Indian Reorganization Act (25 U.S.C. § 476) and is federally recognized by the United States Government through the Secretary of the Interior and the Bureau of Indian Affairs; and THE United States Environmental Protection Agency: and
- WHEREAS, the Pyramid Lake Paiute Tribe, pursuant to Article VI, Section 1 of the Constitution and By-laws of the Tribe, the Pyramid Lake Tribal Council is responsible for planning and implementation of policy that directly affects the environment on the reservation; and
- WHEREAS, the Pyramid Lake Paiute Tribal Council realizes the importance of the immediate and effective emergency response communications; and
- WHEREAS, the Pyramid Lake Paiute Tribe, maintains an Emergency Response Department for the purpose of responding to emergencies both natural and man-made; and
- WHEREAS, the Washoe County Regional Communication System is developing an 800 MHz radio system to enhance the emergency response communications in Washoe County; and
- **WHEREAS,** the Washoe County Regional Communication System will use the Marble Bluff site to install 800 MHz equipment to enhance emergency response communications on the reservation; and
- WHEREAS, the two entities desire to mutually assist each other in the enhancement of emergency response communications by signing the Interlocal Agreement; and
- NOW, THEREFORE BE IT RESOLVED, that the Pyramid Lake Paiute Tribal Council hereby approves the Interlocal Agreement and Marble Bluff site between the Pyramid Lake Paiute Tribe and the Washoe County Regional Communications System; and
- **BE IT FINALLY RESOLVED, that** the Tribal Chairwoman will have the authority to execute the renewal of this agreement.
