## **RESOLUTION OF THE TRIBAL COUNCIL OF THE PYRAMID LAKE PAIUTE TRIBE NIXON, NEVADA**

**WHEREAS,** the Pyramid Lake Paiute Tribe is organized pursuant to the provisions of Section 16 of the Indian Reorganization Act (25 U.S.C. § 476) and is federally recognized by the United States Government through the Secretary of the Interior and the Bureau of Indian Affairs; and

**WHEREAS,** the Pyramid Lake Paiute Tribal Council is the duly elected governing body of the Pyramid Lake Paiute Tribe charged with the responsibility of establishing policy and taking action to preserve and protect the health and general welfare of the Tribal membership; and

**WHEREAS,** the Pyramid Lake Paiute Tribe, pursuant to Article VI, Section 1 of the Constitution and By-laws of the Tribe, is authorized to manage its own accounts and funds; and

**WHEREAS,** the Pyramid Lake Paiute Tribe is eligible to receive funding through the Local Assistance and Tribal Consistency Fund established under the American Rescue Plan Act (ARPA); and


**WHEREAS,** the Pyramid Lake Paiute Tribe recognizes that the Local Assistance and Tribal Consistency fund reserved funding to allocate and pay to eligible Tribal governments for each of fiscal years 2022 and 2023, taking into account economic conditions of each eligible Tribe.

**NOW, THEREFORE BE IT RESOLVED,** that the Pyramid Lake Paiute Tribal Council hereby approves, supports, and authorizes the submittal of the grant application to the United States Department of the Treasury,

**BE IT FINALLY RESOLVED,** that the Pyramid Lake Paiute Tribal Council authorizes the Tribal Chairperson or designee to execute the documents to achieve the intents and purposes of this Resolution.

### **CERTIFICATION**
