RESOLUTION OF THE TRIBAL COUNCIL OF THE PYRAMID LAKE PAIUTE TRIBE NIXON, NEVADA

- WHEREAS, the Pyramid Lake Paiute Tribe is organized pursuant to the provisions of Section 16 of the Indian Reorganization Act (25 U.S.C. § 476) and is federally recognized by the United States Government through the Secretary of the Interior and the Bureau of Indian Affairs; and
- WHEREAS, the Pyramid Lake Paiute Tribal Council is the duly authorized governing body of the Pyramid Lake Paiute Tribe by the authority of Article VI, Section 1 of the Constitution and By-laws of the Tribe; and
- **WHEREAS,** the Pyramid Lake Tribal Council is charged with the responsibility to preserve the history and culture of the Pyramid Lake Paiute Tribe; and
- WHEREAS, the Association of Tribal Archives, Libraries and Museums is currently seeking applications for "Sustaining the Humanities through the American Rescue Plan" (SHARP) program; and
- WHEREAS, the Pyramid Lake Museum is a cultural organization that provides humanities programming and faced hardships due to closure and economic impacts related to the COVID-19 pandemic; and
- WHEREAS, the Pyramid Lake Museum is requesting to submit a grant application for \$49,517.60 which would help the museum recover from the COVID-19 pandemic, continue core functions and activities; conduct community outreach programs; retain staff; and reengage the community with new exhibits/programs;
- NOW, THEREFORE BE IT RESOLVED, that the Pyramid Lake Paiute Tribal Council, hereby approves the application to the Association of Tribal Archives, Libraries and Museums for Sustaining the Humanities through the American Rescue Plan for \$49,517.60;
- **BE IT FURTHER RESOLVED,** that the Tribal Chairperson or designee is hereby authorized to sign the grant application.
