## **RESOLUTION OF THE TRIBAL COUNCIL OF THE PYRAMID LAKE PAIUTE TRIBE NIXON, NEVADA**

**WHEREAS,** the Pyramid Lake Paiute Tribe is organized pursuant to the provisions of Section 16 of the Indian Reorganization Act (25 U.S.C. § 476) and is federally recognized by the United States Government through the Secretary of the Interior and the Bureau of Indian Affairs; and

**WHEREAS,** the Pyramid Lake Paiute Tribal Council (Tribal Council) is the duly elected governing body of the Pyramid Lake Paiute Tribe, charged with the responsibility of establishing policy and taking action to preserve and protect the health of and general welfare of the Tribal membership; and

**WHEREAS,** the Tribal Council established a Tribal Health Clinic in 1985 under the authority of Article VI, Section 1 (A), (D), and (M), of the Tribe's Constitution and By-Laws, adopted January 15, 1936, to provide health care services to the members of the Pyramid Lake Paiute Tribe and eligible American Indians/Alaskan Natives; and

**WHEREAS,** the Pyramid Lake Tribal Health Clinic is authorized to operate under a Charter and Plan of Operations with oversight delegated to the Pyramid Lake Health Board as approved by the Tribal Council on July 12, 2002, amended March 26, 2013; and

**WHEREAS,** the Pyramid Lake Tribal Health Clinic maintains the goal of providing public health promotion prevention activities and health care services that improves the health of the Tribal members and the community; and

**WHEREAS,** the Pyramid Lake Tribal Health Clinic recognizes diabetes as a major health issue for American Indian and Alaskan Native communities; and

**WHEREAS,** the Department of Health and Human Services, Special Diabetes for Indians Program (Announcement #HS-HIDII-23-001-100754) is providing a funding opportunity for diabetes clinical and prevention programs; and


**WHEREAS,** the Pyramid Lake Tribal Health Clinic, Diabetes Prevention Program, has developed a Special Diabetes for Indians grant application for a five (5) year Program, 2023-2027, \$439,579.00 a year, to provide diabetes clinical and prevention services to eligible participants within the boundaries of the Pyramid Lake Paiute Reservation.

**NOW, THEREFORE BE IT RESOLVED,** that the Pyramid Lake Paiute Tribal Council, hereby approves the submittal of the Department of Health and Human Services, Indian Health Service, Special Diabetes Programs for Indians grant application; and

**BE IT FURTHER RESOLVED,** that the Tribal Chairman or designee is hereby authorized to effectuate any and all administrative actions necessary to implement the intent of this Resolution.

**CERTIFICATION**

It is hereby certified that the foregoing resolution of the Pyramid Lake Paiute Tribal Council, governing body of the Pyramid Lake Paiute Tribe, composed of ten members, of whom ten (10) constituting a quorum were present at a meeting duly held on the 17<sup>th</sup> day of March 2023, was adopted by the affirmative vote of nine (9) FOR and zero (0) AGAINST, with zero (0) ABSTENTIONS; pursuant to the authority contained in the Constitution and By-laws of the Pyramid Lake Paiute Tribe.
