RESOLUTION OF THE TRIBAL COUNCIL OF THE PYRAMID LAKE PAIUTE TRIBE NIXON, NEVADA

- WHEREAS, the Pyramid Lake Paiute Tribe is organized pursuant to the provisions of Section 16 of the Indian Reorganization Act (25 U.S.C. Section § 476) and is federally recognized by the United States Government through the Secretary of the Interior and the Bureau of Indian Affairs; and,
- WHEREAS, the governing body of the Pyramid Lake Paiute Tribe of Nevada, Tribal Council is organized under the provisions of the said Indian Reorganization Act of June 18, 1934 (48 Stat.98), is responsible for the promotion of cultural, economic and social welfare of its tribal members; and,
- WHEREAS, the Pyramid Lake Paiute Tribe through the Transportation Planning Department have constructed Wadsworth Complete Streets Project PLIR 447(1) a cooperative project with Nevada department of Transportation which included a multi-use path which encroached on existing housing lots bordering State Route 447; and,
- WHEREAS, the Transportation Planning Department has retained the services of Arrow Pro Land Surveys to prepare a revised housing lot map that accurately displays the affected lots and the corrected lot areas.
- **NOW, THEREFORE BE IT RESOLVED** that the Pyramid Lake Paiute Tribal Council hereby approves the revised housing map identified as follows:
 - "Record Of Survey Pyramid Lake Indian Reservation Jackson Street Adjusted Subdivision Lots Portion of the Northeast 1/4 of Section 4, T.20 N., R.24E. Mount Diablo Meridian, Pyramid Lake Indian Reservation, Washoe County, Nevada", Sheets 1 and 2, dated January 2023 and signed by James S. Darrough, P.L.S., on 01/24/2023.
- **BE IT FUTHER RESOLVED** that the Pyramid Lake Paiute Tribal Council approves the above stated map to create Adjusted Cheryl Christenson Lot, Adjusted New Moon Yellowhair Lot, Adjusted Wendy Garcia Lot, Adjusted Lot W9, Adjusted Lot W8, Adjusted Alberta Catha Lot, Adjusted Velda Kaye Lot, and Adjusted Lot W7, as shown thereon, and that the above stated shall replace the original housing survey map for the affected lots, and,
- **BE IT FINALLY RESOLVED** that the Pyramid Lake Paiute Council authorizes the Chairman, or designee to execute any and all documents necessary to facilitate the intent of this resolution.
