RESOLUTION OF THE TRIBAL COUNCIL OF THE PYRAMID LAKE PAIUTE TRIBE NIXON, NEVADA

whereas, the Pyramid Lake Paiute Tribe, is organized pursuant to the provisions of Section 16 of the Indian Reorganization Act, (25 U.S.C. 476) and is Federally recognized by the United States Government through the Secretary of the Interior to work with the Environmental Protection Agency; and

WHEREAS, the Environmental Protection Agency is soliciting for eligible projects under its – Solid Waste Infrastructure Recycling Grant to approve all eligible projects for funding considerations and obtain funding for improvement to the Recycling Program by buying needed equipment and renovations for the benefit of the Tribe; and

whereas, the grant program provides funding for the purchase of equipment for the transfer site and recycling building, renovating the recycling building, provide collection containers for PUD customers and a collection area constructed at the transfer site for recycling while building capacity within the Natural Resources Department; and

WHEREAS, the management of the Environmental programs on the Pyramid Lake Reservation would allow the tribe to provide more efficient and expanded recycling services for environmental protection of the natural resources and other Tribal Trust Resources; and

Whereas, the proposal being submitted is consistent past with planning, development, and implementation efforts towards recycling and environmental protection on the Pyramid Lake Indian Reservation for the betterment of the Tribe and its members.

NOW, THEREFORE, BE IT RESOLVED, that the Pyramid Lake Paiute Tribal council hereby approves, supports, and authorizes the submittal of the proposal to the Environmental Protection Agency, Solid Waste Infrastructure Grant to perform tasks to be incorporated in the Tribal Recycling Program for the Pyramid Lake Reservation.

BE IT FURTHER RESOLVED, that the Tribal Chairman or designee be hereby authorized to negotiate and sign all grant awards and other future administrative documents necessary for project award and implementation.
