RESOLUTION OF THE TRIBAL COUNCIL OF THE PYRAMID LAKE PAIUTE TRIBE NIXON, NEVADA

- WHEREAS, the Pyramid Lake Paiute Tribe is organized pursuant to the provisions of Section 16 of the Indian Reorganization Act of June 18, 1934 (25 USC, §467), and is Federally recognized by the United States Government through the Secretary of the Interior and Bureau of Indian Affairs; and,
- WHEREAS, under Article II of the Constitution and By-Laws, the Tribe has the power to propose ordinances governing the future membership and the adoption of members into the Tribe, provided that no existing property rights be affected; and,
- **WHEREAS**, Ordinance I, Ordinance II, Ordinance 1-89, and Ordinance III, Ordinance III (*first revision*) have been adopted by the Pyramid Lake Paiute Tribal Council to govern membership in the Pyramid Lake Paiute Tribe; and,
- WHEREAS, Article VIII of said ordinance provides as follows: "Persons found to be meet one of the following criteria will be considered for disenrollment: A. is enrolled or affiliated with any other tribe, colony or band, and who refuses or fails to relinquish his or her membership and/or affiliation with any other tribe, colony or band."
- **NOW, THEREFORE, BE IT RESOLVED THAT**, it is the decision of the Pyramid Lake Paiute Tribal Council to disenroll the following individual who has been determined to be enrolled in another federally recognized tribe:

David Paul Alan Skinner PL03388

Termination of membership shall be effective this date forth, and notice shall be given that all rights and privileges of the above-named as a member of the Pyramid Lake Paiute Tribe are hereby terminated. The above-named individual is hereby removed from membership and their name will not appear on subsequent membership rolls of the Pyramid Lake Paiute Tribe.
