RESOLUTION OF THE TRIBAL COUNCIL OF THE PYRAMID LAKE PAIUTE TRIBE NIXON, NEVADA

- WHEREAS, the Pyramid Lake Paiute Tribe ("Tribe") is organized pursuant to the provisions of Section 16 of the Indian Reorganization Act of June 18, 1934 (25 U.S.C. § 476), and is federally recognized by the United States government through the Secretary of the Interior and the Bureau of Indian Affairs; and
- WHEREAS, in accordance with its Constitution and By-Laws, the Tribe is governed by its Tribal Council; and
- WHEREAS, the Tribe previously negotiated and approved in 1997 a compact governing Class III gaming with the State of Nevada (the "State") in accordance with the Indian Gaming Regulatory Act, 25 U.S.C. §§ 2701 et seq.; and
- WHEREAS, the compact was extended a number of times, and in 2009 a new compact was adopted to replace the original expired compact under the same terms as the prior compact; and
- WHEREAS, the 2009 compact was for a two year term expiring on February 23, 2012, and it contained a provision allowing the Tribe and the State to extend the compact for additional periods of up to twenty years without the additional approval of the Secretary of the Interior; and
- WHEREAS, the Tribe and the State executed a one-year extension of the compact, which expired on February 23, 2013, then executed a two-year extensions of the compact that expired on February 23, 2015, February 23, 2017 and February 23, 2019, then executed another two-year extension of the compact that will expire on February 23, 2021; and
- WHEREAS, the Tribe and State wish to extend the compact for an additional two year term and have prepared a document to accomplish this extension, which the Tribal Council has reviewed and has determined that the extension to the compact should be approved;
- NOW, THEREFORE BE IT RESOLVED, that the Pyramid Lake Paiute Tribal Council hereby approves the sixth extension of the gaming compact between the Pyramid Lake Paiute Tribe and the State of Nevada governing Class III gaming, in substantially the form attached to this Resolution.
- **BE IT FINALLY RESOLVED**, that the Tribal Chairman is hereby authorized to sign any documents necessary to execute the fourth extension of the gaming compact on

behalf of the Pyramid Lake Paiute Tribe, and is authorized to take additional actions and execute such additional documents as are necessary to carry out the terms and intent of this Resolution.
