RESOLUTION OF THE TRIBAL COUNCIL OF THE PYRAMID LAKE PAIUTE TRIBE NIXON, NEVADA

WHEREAS, the Pyramid Lake Paiute Tribe, is organized pursuant to the provisions of Section 16 of the Indian Reorganization Act, (25 U.S.C. 476) and is Federally recognized by the United States Government through the Secretary of the Interior to work with the Environmental Protection Agency; and

WHEREAS, the Environmental Protection Agency is soliciting for annual General Assistance Funding to Tribal governments to assist tribes in planning, developing, and establishing the capacity to implement federal environmental programs administered by the EPA and assist in implementation of Tribal solid and hazardous waste; and

WHEREAS, the Environmental Protection Agency provides funding support to protect ecosystems, promote safe and quality living environments and strong communities, while protecting the lives, prosperity, and well-being of American Indians.; and

WHEREAS, the Tribe has continuously received the General Assistance Funding for over 20 years which has allowed the Tribe to build on the capacity of the Tribal Natural Resources Department to help protect Tribal Resources; and


WHEREAS, the proposal being submitted is consistent with planning and development efforts in the Natural Resources Department in the EPA Tribal Environmental Plan (ETEP) used for strategic planning of resources on the Pyramid Lake Indian Reservation for the betterment of the Tribe and its members.

NOW, THEREFORE, BE IT RESOLVED, that the Pyramid Lake Paiute Tribal council hereby approves, supports, and authorizes the submittal of the proposal to the Environmental Protection Agency, for the General Assistance Program (GAP) Grant.

BE IT FURTHER RESOLVED, that the Tribal Chairwoman or her designee by hereby authorized to negotiate and sign all grant awards and other future administrative documents necessary for project award and implementation.

CERTIFICATION
