The laws governing the Pyramid Lake Paiute Reservation allow any person to represent him/herself in any legal action heard in the Pyramid Lake Tribal Court. However, filing Petitions/Application/Complaints with the Court and representing yourself in the Courtroom can involve complex legal matters. This packet only addresses a few legal issues involved in bringing your matter before Court.

When appearing pro se, Latin for "on one's own behalf", you are responsible for understanding the law that governs your case and for filing the correct legal documents. The laws and rules are set out in the Pyramid Lake Law & Order Code, the Federal Rules of Civil Procedure, and the Pyramid Lake Tribal Court Operational Procedures.

When you return to the Court and sign these documents for filing, the Court assumes that all documents are read carefully and all potential outcomes of litigation in this matter are understood.

**BEFORE FILING IN ANY PORTION OF THE APPLICATION, READ ALL

MATERIALS AND, IF NEEDED, REQUEST CLARIFICATION FROM THE COURT

STAFF.**

- 1. Fill out the Application and Affidavit for Revocable Drivers License (herein after "Application") completely. Use blue or black ink only to fill out the forms and neatly print the information requested. DO NOT USE WITE-OUT or any other fluid/tape on the forms. The Application will not be accepted by the Court Personnel if correction fluid/tape is used.
- 2. A DMV Printout is required to be submitted with the Application, or the Application will be denied.
- 3. If you plan on returning to the Courthouse to file the Application, wait to sign the Application in front of staff so they may sign stating that the signature was witnessed. However, if you are mailing, emailing, or faxing the Application, have each area designated for a signature, notarized.
- 4. Once the Application is completed and ready to be filed, submit the filing fee (\$30.00), and the complaint to Court Personnel; If you are submitting your Application with an Application Waive Filing Fees (herein after: "Fee Waiver") the Application will not be filed until a decision on the Fee Waiver is rendered. Should the Judge approve the Fee Waiver, your Application will be filed, however, if it is denied, you will be contacted and must pay the filing fee prior to the Application being filed. If the Fee Waiver is approved, no filing fees will be assessed for thirty (30) days per Fee Waiver.
- Once the Application is filed, Court staff will send the Application and the DMV Print out to the Judge to issue an Order within ten (10) days.
