ATTENTION: THIS PACKET IS NOT A SUBSTITUE FOR THE ADVICE OF AN ATTORNEY

OR ADVOCATE. COUNSEL IS ALWAYS RECOMMENDED FOR LEGAL MATTERS.

The laws governing the Pyramid Lake Paiute Reservation allow any person to represent him/herself in any legal action heard in the Pyramid Lake Tribal Court. However, filing Petitions/Application/Complaints with the Court and representing yourself in the Courtroom can involve complex legal matters. This packet only addresses a few legal issues involved in bringing your matter before Court.

When appearing pro se, Latin for "on one's own behalf", you are responsible for understanding the law that governs your case and for filing the correct legal documents. The laws and rules are set out in the Pyramid Lake Law & Order Code, the Federal Rules of Civil Procedure, and the Pyramid Lake Tribal Court Operational Procedures.

When you return to the Court and sign these documents for filing, the Court assumes that all documents are read carefully and all potential outcomes of litigation in this matter are understood.

- Fill out the Application completely. Use blue or black ink only to fill out the form and print the information neatly. DO NOT USE WITE-OUT or any other fluid/tape on the forms. The Notice will not be accepted by the Court personnel if correction fluid/tape is used.
 - ** Also, the following section of the Pyramid Lake Law & Order Code (herein after "P.L.L.O.C.") references the statute of limitations which gives a time limit to file an Appeal: §3.2.306: "Any party may appeal a final decision or judgment of the Tribal Court by filing a written notice of Appeal with the Clerk of the Court within thirty (30) calendar days of service of the formal notice of the entry of the Judge's decision."
- 2. Write the Plaintiff or Applicant above "Plaintiff";
- 3. Write the Defendant/Respondent above "Defendant";
- 4. Pg. 1 #2: write BOTH your physical and mailing address, your phone number, and date of birth.
- 5. Pg. 1 #3: Check if you are buying or renting; if renting who's the home owner?
- 6. Pg. 1 #4: Write who your employer is, the address, and phone number.
- 7. Pg. 1 #5: Write the last name address of the respondent, we can NOT Look it up and give it to you.
- 8. Pg. 1 #6: Write the last name employer for the Respondent, address and number;
- 9. Pg. 1 #7: Write the relationship (Ex: Neighbor, Co Worker, Etc.) and the length of the relationship.
- 10. Pg. 2 #8: Write the names of the children you wish to be listed on the restraining order, along with age, date of birth, and if you have custody.
- 11. Continue down Pg. 2 and Pg. 3 and check any one that applies to you and your situation:
- 12. Don't not sign until in front of a Notary or Court Staff;
- 13. Pg. 4 6: Please explain in detail why you believe a restraining order is necessary. The Judge will review this to make his decision, please give as many details as possible and submit any police reports and/or evidence you have as well.
