MOTION FOR CONTINUANCE

PACKET INCLUDES INSTRUCTIONS AND FILING PROCESS

ATTENTION: THIS PACKET IS NOT A SUBSTITUE FOR THE ADVICE OF AN ATTORNEY OR ADVOCATE. COUNSEL IS ALWAYS RECOMMENDED FOR LEGAL MATTERS.

The laws governing the Pyramid Lake Paiute Reservation allow any person to represent him/herself in any legal action heard in the Pyramid Lake Tribal Court. However, filing Petitions/Application/Complaints with the Court and representing yourself in the Courtroom can involve complex legal matters. This packet only addresses a few legal issues involved in bringing your matter before Court.

When appearing pro se, Latin for "on one's own behalf", you are responsible for understanding the law that governs your case and for filing the correct legal documents. The laws and rules are set out in the Pyramid Lake Law & Order Code, the Federal Rules of Civil Procedure, and the Pyramid Lake Tribal Court Operational Procedures.

When you return to the Court and sign these documents for filing, the Court assumes that all documents are read carefully and all potential outcomes of litigation in this matter are understood.

BEFORE FILING IN ANY PORTION OF THE PETITION, READ ALL MATERIALS AND, IF NEEDED, REQUEST CLARIFICATION FROM THE COURT STAFF.

- 1. Motions for Continuance must be submitted 13 days in advance unless in the case of an emergency. Fill out the Motion for Continuance completely. Use blue or black ink only to fill out the form and print the information neatly. DO NOT USE WITE-OUT or any other fluid/tape on the forms. The Notice will not be accepted by the Court personnel if correction fluid/tape is used.
 - ** Also, the following section of the Pyramid Lake Law & Order Code (herein after "P.L.L.O.C.") references the statute of limitations which gives a time limit to file an Appeal: §3.2.306: "Any party may appeal a final decision or judgment of the Tribal Court by filing a written notice of Appeal with the Clerk of the Court within thirty (30) calendar days of service of the formal notice of the entry of the Judge's decision."
- 2. Write the name of the case on the top box;
- 3. Write the date of request;
- 4. Write the Case No. of the case requesting the continuance;
- 5. Write the name of the Judge presiding over the case;
- 6. Write the date of the scheduled hearing;
- 7. Check what kind of hearing is scheduled;
- 8. Check the reason of the request;
- 9. Check if all parties are in agreement or not;
- 10. Once the Motion is complete and ready to be filed submit the filing fee (\$15.00) and the Motion for Continuance to Court Personnel. Please ensure you give a copy to the opposing party prior to filing.
- 11. Once the Motion for Continuance is received, if requested by parties, the Court personnel will serve the opposing party with the Motion. They will have 14 days to respond, then the matter will be set for a hearing.
