2023 Tribal Wage Schedule

RESOLUTION OF THE TRIBAL COUNCIL OF THE PYRAMID LAKE PAIUTE TRIBE NIXON, NEVADA

WHEREAS the Pyramid Lake Paiute Tribe is organized pursuant to the provisions of Section 16 of the Indian Reorganization Act and is federally recognized by the United States Government through the Secretary of the Interior; and

WHEREAS the Pyramid Lake Paiute Tribal Council is the duly elected governing body of the Pyramid Lake Paiute Tribe, charged with the responsibility of establishing policy and taking action to provide administrative guidelines; and

WHEREAS, the Pyramid Lake Paiute Tribal Council established a Tribal Personnel Committee to review the Personnel Policies and Procedures Manual, recommending revisions by resolution determined necessary for the proper management and administration of the Personnel System; and

WHEREAS, the last Tribal Wage Schedule was last updated in June 2021 with Tribal Council Resolution PL068-21; and

WHEREAS, the Personnel Committee has determined it necessary the current Wage Schedule needs to be increased by 3%; to recruit for the multitude of job announcements and to reduce the number of reclassifications solely for increasing the salaries, and


WHEREAS, the Personnel Committee reviewed the proposed revisions to the 2023 Tribal Wage Schedule and recommends approval to the Tribal Council; and

NOW, THEREFORE, BE IT RESOLVED that the Pyramid Lake Paiute Tribal Council, governing body of the Pyramid Lake Paiute Tribe, hereby accepts the recommendation of the Personnel Committee and approves the revision of the 2023 Tribal Wage Schedule.

BE IT FINALLY RESOLVED that the Pyramid Lake Paiute Tribal Council, authorizes the Tribal Chairman or designee to implement this revision.

CERTIFICATION
