## RESOLUTION OF THE TRIBAL COUNCIL OF THE PYRAMID LAKE PAIUTE TRIBE NIXON, NEVADA

**WHEREAS,** the Pyramid Lake Paiute Tribe is organized pursuant to the provisions of Section 16 of the Indian Reorganization Act (25 U.S.C. § 476) and is federally recognized by the United States Government through the Secretary of the Interior and the Bureau of Indian Affairs; and

**WHEREAS,** the Pyramid Lake Paiute Tribe wishes to engage in contract renewals with the Bureau of Indian Affairs (BIA) to provide existing critical services for the Tribe; and,

**WHEREAS,** the Scopes of Work and the proposed budgets have been provided to the Bureau of Indian Affairs and the proposals are consistent with the needs, priorities, and strategic efforts of the Pyramid Lake Paiute Tribe for the betterment of the Tribe and its members; and,

**WHEREAS,** these Scopes of Work cover the following programs; and,



**BE IT FURTHER RESOLVED,** that the Tribal Chairman or designee is hereby authorized to negotiate and sign all grant awards and other future administrative documents necessary for project award and implementation,

**BE IT FINALLY RESOLVED THAT,** the Pyramid Lake Tribal Council hereby requests that this funding be added to the existing 638 contracts.
