





#### **NOTICE TO ELIGIBLE VOTERS**

The Pyramid Lake Paiute Tribe will hold a General Election on December 28, 2024, in the Tribal Council Chambers from 6:00 AM until 6:00 PM, for the offices of Tribal Chairman, Tribal Vice Chairman, four (4) Tribal Council positions and to fill two (2) vacancies on the Pyramid Lake High School Board of Education.

In accordance with the Constitution of the Pyramid Lake Paiute Tribe, eligible voters in this election are defined in Amendment B, Article IV - Nominations and Elections, Section 4 which reads "Any member of the Pyramid Lake Paiute Tribe who is 18 years or older shall be considered eligible and entitled to vote."

Eligible Pyramid Lake voters may cast their ballot in-person at the Tribal Council Chambers between 6am and 6pm on December 28, 2024. Voters who do not plan on voting In-Person on December 28, 2024, MUST request an Absentee Ballot in writing using the enclosed Absentee Ballot Request Form. To receive an Absentee Ballot, Voters must complete the Absentee Ballot Request Form, sign it and return it in the Prepaid envelope provided.








My name is Brian Wadsworth, and I am running for Pyramid Lake Paiute Tribal Vice Chairman. I was born and raised in Wadsworth. I currently live in my grandma Dow's house in Nixon, where I have resided since May 2023. My mother is Berneys Wadsworth and my father is William Wadsworth, Sr. My paternal grandparents are Genevieve and Leonard Wadsworth. My maternal grandmother is Juanita Ross. I am running for Tribal Vice Chairman, because I want to make a positive impact and change for our Numu-today and for our next 7 generations. Since the last time I was on Tribal Council, I have devoted my time in serving our people throughout the state

and country, and advancing my education.



I currently work remotely as the Financial Director for Native Public Media (NPM). NPM is a Native-led non-profit that works with a network of Tribally-licensed radio and television stations throughout

the country on various broadcasting matters. As the Financial Director, I direct NPM's fiscal management, investment management, and work with Tribally licensed radio stations on their financial compliance. With NPM, I have devoted my time in advocating for the Federal Communications Commission's rulemaking for the Missing and Endangered Persons Event code. This event code is important for the protection of all our Indigenous relatives. I am fortunate in my position to get to travel all over the country to different Reservations, give presentations at various conferences, and engage with Tribal leaders and federal and state agencies.

I have the honor of serving as Board Treasurer for the American Indian Alaska Native Tourism Association; Vice-Chair for Nevada's Indian Territory; Commissioner for the Pyramid Lake Paiute Tribe's Tax Commission; and, Vice-President of the University of Nevada, Reno-Native American Alumni Chapter. I also had the honor to serve on the Commission for the Nevada Department of Native American Affairs (formerly known as the Nevada Indian Commission) from 2018 to 2024.



For the past two years, I have volunteered with the Sacred Visions Pow Wow Committee and have taken the lead on directing the Sacred Visions Royalty Pageant. During my time volunteering with the Sacred Visions Pow Wow Committee, I have helped raise over \$15,000 from the Pageant; successfully wrote a grant to secure over \$6,000 from the Fernley Convention and Tourism

Authority, as well as bringing in community partners; and providing ribbon skirts and school supplies for all our contestants.

Over the past several years, I have made it a point to attend as many Tribal Council meetings as possible to keep myself informed about what is going on with our Tribe. One major recurring issue is the financial health of our Tribe. Most recently, the Tribal Council approved a 20%



budget cut to all Tribally funded programs. This could drastically affect the services provided to our people. With my accounting and auditing background, it would help get our Tribal finances back under control. It makes it difficult for the Tribal Council to make informed decisions if they do not know how much money they actually have in their bank accounts. I would like the propose the Tribal Council follow the Constitution and appoint a Tribal Treasurer to work with the Comptroller.

If elected, I will advocate for our Numu to have an ongoing annual distribution for our membership from the interest monies from the Economic Development fund. I feel it is time for our Tribal leadership to think our people and help our people-both on and off Reservation. In addition to this annual distribution, I would advocate for projects to promote economic development on the Reservation. A travel center was green lit by the Tribal Council several years ago, but has not happened; the new Wadsworth Bypass Road project could spark economic development of an Industrial Center; we could use the amazing asset of the fiber optics to get a data center; and, we could also expand our tourism efforts on the Reservation. There are a lot of other areas the Tribe could go, but it takes a Tribal Council with vision and not afraid to take a chance. The economic prosperity of the Tribe benefits all of our membership and is endless.

I am an animal advocate. I would like to work on ways to get free spay and neuter and vaccination clinics for our animals. We also need to take care of our Elders. I would like to advocate for more services for our Elders. This could be in the form of advocating for more funding for our Numaga Senior Center, and ways to provide services for our off-Reservation elders.

If elected, I would like to create an environment of positivity and team work. Our Tribal Council works best when everyone is on the same page and working towards a common goal. I have a diverse background in accounting and finance; I have extensive experience in working with Tribal Leaders and Federal and State officials; and, most importantly, I am passionate about advancing our Numu and protecting all our resources and Kooyooe. A vote for me would be a vote for someone with a vision for our Numu and willing to speak up when necessary and hold our Tribal Leadership accountable and be a strong advocate for all of our membership.



# "What it means to be Miss Sacred Visions."



If you are age 18 by December 31, 2024, and on the approved list of eligible Pyramid Lake Paiute Tribal members per Resolution PL#34-18, then you are eligible to apply for the Minor's Trust. (See Resolution on our website at plpt.nsn.us/enrollment). This is for those enrolled as a Pyramid Lake Paiute Tribal member and living as of April 6, 2018.)

- Minors will have up to six years to complete their forms and claim their economic stimulus payment. The deadline to submit your forms for this 4th Quarter of 2024 is on the last Tuesday of December 2024. Applications received by 12/31/24 will be processed and forwarded to the Trust the next business day.
- Tribal members under the age of 18 will have their economic stimulus payment placed in a trust account to be managed by the Trust until they reach 18 years of age.
  - Members who will receive their payment from the Minor's Trust can expect distributions within one month after the end of the calendar quarter (March, June, September, or December) after they return the completed and signed application.
  - Members who have an account in the Minor's Trust will have six years to claim their economic stimulus payment, from the date of their 18th birthday.

- 1. Funds will be received at least 1-2 months after quarter deadline. Please plan accordingly.
- All Minors' Applications are processed at the same time turning in a form earlier than the deadline doesn't ensure a faster result.

#### NOTE: \*\*You may turn in your form earlier, but it will be held until the appropriate Quarter Deadline your birthday falls under.\*\*

- 3. The whole process goes from receiving and verifying your information with our PLPT Enrollment office, which includes verifying Enrollment numbers, social security numbers and updated addresses. The paperwork is then submitted to the Trust Company, where it is then processed there for at <u>least a month</u>. The Trust Company then submits their completed forms to the Bank, and after verification with the bank, your money will THEN be distributed this sometimes takes up to 1-2 MONTHS. Please plan accordingly, and expect that your money will arrive 1-2 MONTHS after the Quarter Deadline.
- 4. The Trust company will contact the PLPT office for more information according to their standards your contact information needs to be legible just in case we need to reach you. If you can't be reached, your form will be held until you contact us.
