

Secret Witness is now offering a \$5,000 reward for information leading to an arrest in the death of Anna Marie Scott.

Anna Marie Scott was brutally murdered on February 3, 2022. She was shot, her body then stuffed into her car, which was set on fire on I-580 Southbound at the Galena Creek Bridge. She was a mother of two, a sister, a daughter, a granddaughter, a cousin, a friend – she was our relative.

As of April 3, 2025, her murderers continue to remain free. If you know something, SAY SOMETHING.

From Joe Hart KRNV Facebook post, March 21, 2025: "Ask Joe: -Sparks sewer spill issue heads to the Legislature-

"I think it's totally reasonable for them to say what in the hell happened?"

Senator Ira Hansen (R) Washoe County testified in support of his bill SB 276 which came about after we reported a major sewer spill from a Sparks apartment complex was never reported to the Nevada Department of Environmental Protection or downstream users, including the Pyramid Lake Paiute Tribe.

Tribal Chairman Steven Wadsworth says he found out about the spill by watching our story on KRNV News 4.

Sen. Hansen's bill would tighten up language in existing law and require mandatory reporting to neighboring jurisdictions.

"Bottom line to me I have a few thousand people on an indian reservation who received 2 million gallons of sewage in their drinking water supply and somehow nobody notified them of that," Hansen stated on Thursday.

The bill will undergo some fine tuning before it comes up for a vote."

STATE LAUNCHES INVESTIGATION AFTER QUESTIONS FROM NEWS 4 ABOUT SPARKS SEWER MISHAP

Reno, NEV — A foul odor that plagued a Sparks neighborhood has been traced back to a significant error involving a newer apartment complex's sewer line, city officials confirmed. Scott Trabert, a resident of "C" Street, described the smell as a "foul, foul sewer smell," which kept him from enjoying his backyard.

Trabert said he sought answers by contacting the city through emails, calls, and eventually visiting city hall. The city of Sparks revealed that the odor originated from the Atrium Apartments, where construction crews mistakenly connected the building's sewer line to a storm drain instead of the sewer treatment plant. This error resulted in raw sewage flowing into the Truckee River.

Jennifer Carr, administrator for the Nevada Department of Environmental Protection (NDEP), expressed concern, stating, "Raw untreated wastewater does not belong in the river."

City officials attributed the mistake to human error, but no representatives were willing to comment on camera. Trabert speculated, "I think they were embarrassed and didn't know how to react."

In October 2023, construction crews provided video evidence to city officials confirming the repairs. However, the issue was never reported to state environmental officials, as required by law. The city claimed it was the builder's responsibility to report the incident, but Silverwing Development, now out of business, failed to do so.

Carr said, "We were unaware until you started asking questions about it. So we very much appreciate Channel 4." NDEP has since launched an investigation to assess the environmental impact, including the duration and volume of the discharge.

Potential fines could reach \$25,000 per day, depending on the investigation's findings. Trabert expressed relief at the resolution, saying, "I'd just hate for that to be happening running into our beautiful river."

The city of Sparks has implemented a new policy to report environmental issues directly to the state, rather than relying on builders or contractors. The investigation is ongoing, with results and potential fines expected in the coming weeks.

What do I do if I get an Ambulance Bill from the Tribe

As an Enrolled member or legal spouse, of the Pyramid Lake Paiute Tribe, our ambulance does not "balance bill" you for our services.

What does that mean? To provide services to the members the EMS must bill insurance companies to help offset the high cost of ambulance services. So, if you're a member and your insurance does not pay the entire bill, we do not Balance bill you for the remainder instead the Tribe writes off the bill as a loss. For example, if your bill is \$1,000.00 and your insurance only pays \$800.00 we write off the balance of \$200.00.

What if I get a bill? If you receive a bill from the Pyramid Lake Fire Rescue/EMS it most likely means one or two things happened. 1) our medics did not get your PLPT enrollment number this is what we use to keep from balance billing our Tribal members. 2) Our medics did not get any or enough insurance information from you to be able to bill the insurance company. We understand that when you are sick or injured these things are not your priority at the time.

I received an Ambulance bill what do I do with it? Most importantly do not throw it away or ignore it, that can cause the bill to go to a collection agency. If this happens we can no longer help you with the bill and, you will be responsible for settling the debt. Don't let this happen.

Instead, when you receive a bill, call the fire department right away at 775-574-8999 and speak with our on-duty supervisors, they will assist you in obtaining the necessary information and contact the billing company and the bill will be taken care of, at no cost

Can I call or give the bill to the Clinic? No, the fire department is a separate department of the Tribe so going to the clinic will only slow down getting the bill resolved. Again, call the fire department upon receipt of any EMS bills at 775-574-8999.

Your Pyramid Lake Fire Rescue/EMS is always available 24/7 to serve our community.

NSHE Regents' 2025 Honorary Degree Awardee





- 2. Provide individual appointments for children, adolescents and adults with a variety of health diagnoses.
- 3.Collect information about clients using interview, case history, observation techniques and assessment methods to determine reliability and validity of treatment used.
- 4. Perform clinical case management.
- 5. Work in a team setting with medical providers.
- 6. Participate in bi-weekly staff meetings that include clinical case staffing.
