## A message from Chairman Wadsworth:

(04/18/2025): Pyramid Lake Tribal Members,

The Pyramid Lake Tribal Council recognizes that the safety and security of our membership is a top priority. While there have been no known instances of ICE confrontations, the Council has asked to put forth information for your safety and knowledge. This is a sense of uncertainty that we are trying to address as it relates to immigration and this post is aimed at providing a guideline. Some things to remember are:

- If you are approached by anyone claiming to be Law enforcement, you have the right to ask for identification.

- We highly encourage you to carry your Identification. As Tribal People, we are fortunate enough to have access to 2 Official forms of Government Id's and these should always be carried, both on the Reservation and off.

- PLPT Enrollment cards are available for your Children. Again, we are fortunate that we can provide this service to our Tribal Youth. Please contact the Enrollment office for your children.

- Update your Tribal ID so that it has a current picture and address. We cannot stress this enough, the Enrollment cards that don't have an expiration date have been replaced with the new cards, per Tribal Council. These new cards meet the compliance requirements with the NV DMV for Real ID status.

- Always remember to stay calm, cool and collected if you are stopped by any Law Enforcement Official.


As of May 3, 2025, her murderers continue to remain free. If you know something, SAY SOMETHING.



#### **Recycling Program**

In front of the Natural Resources Department Building there are two big blue bins that are for cardboard **ONLY**.

Please DO NOT put any plastic in these bins, including any of the packaging that comes with your big items (foam peanuts, etc.)

There is a three-bin container right next to the copy machine in the tribal office where you can recycle paper, cans, and plastic bottles.

There are bins at the Nixon Gym for plastic bottles only, located on the left side of the stage.

In the front yard of the Natural Resources Department, there are three 30-gallon containers that you can put cans and plastics in.

Also, in the Natural Resources Building there is a shelf where I recycle old household batteries, used printer cartridges and some small E-Waste equipment.

### National RTAP Review Board Member Spotlight – Michele Smith

#### National Rural Transit Assistance Program (RTAP) Facebook post, Friday, April 11, 2025:

Michele Smith, Transit Manager of Pyramid Lake Paiute Tribal Transit, joined the National RTAP Review Board in 2025. She was born in Reno, Nevada, grew up in Carson City, and moved to Wadsworth, one of the Tribe's three communities, after she started her family. Her heritage is part Western Shoshone and part Pyramid Lake Paiute, and Michele had the honor to follow in her father's footsteps and serve on the Pyramid Lake Paiute Tribal Council from 2019-2021. She also followed in her mother and stepfather's footsteps career-wise. Her parents enjoyed careers with the state of Nevada, and when Michele graduated from Carson City High School, she started out working for the state too.

A career in transit was a natural next step for Michele, who did not own a vehicle at one point and took transit to work. "Taking transit made me passionate about transit," explains Michele. "Knowing that I could count on transit made me a better transit manager." She began working for Pyramid Lake Paiute Tribal Transit in 2016 as a transit specialist/dispatcher. When the Transit Manager she had worked for left in 2019, he told her, "I know you can do this job" and put her in charge. It was an exciting time as the transit system just received two FTA Buses and Bus Facilities Grants and was ready to expand its fleet and build a transit facility.

Then the pandemic hit in 2020. Michele worked through many challenges to implement the grants, working closely with FTA Region 9 Tribal Liaison Phil Yue. Not only did she buy 2 buses and oversee the first Tribal Transit facility ever built in the state of Nevada, but she also continued expanding Pyramid Lake Paiute Tribal Transit's reach, purchasing a 3rd bus in 2024, starting a new route, hiring 2 new drivers and a new facilities buildings & groundskeeper, and is in the process of having a bus shed built.


When Michele attended the National RTAP 2023 Technical Assistance Conference in Myrtle Beach, South Carolina, she was awarded the second place Tribal Champion Award. She

was nominated by Phil, who praised Michele's ability to effectively manage teams of people to ensure that projects are completed to the highest standards. Michele was impressed with what a wonderful program National RTAP was and thought that if she ever had an opportunity to participate, she would take it. Another opportunity came when National RTAP Tribal Transit Program Manager Neil Rodriguez invited Michele to present on capital projects at the 2024 National Transportation in Indian Country Conference (NTICC). She is looking forward to serving on our Review Board to represent Tribal Transit on a different level and platform.

Michele is no stranger to technical assistance. Her agency is now providing one-to-one support and guidance to other Tribes establishing transit programs, including the Duck Valley Paiute-Shoshone Tribe and Walker River Paiute Tribe. Assistance is given through phone and in person meetings.

With 5 children and 9 grandchildren (and another on the way), it's no surprise that her favorite thing to do in her spare time is spending time with her grandchildren. She also enjoys spending time on the beautiful Pyramid Lake itself – looking out over the shore and the desert provides her with clarity and focus. Pyramid Lake was the scene used to represent the Sea of Galilee in the movie "The Greatest Story Ever Told" and the lake is her favorite place to be in the summertime. She also is the proud mom of her oldest son, Jon Yarrow Jr., the Director of TRIBE Athletics SPORTS, an organization that holds national basketball tournaments for 400 indigenous youth teams nationwide including, Canada, Alaska, Hawaii, and New Zealand to help expose Native American basketball players to college recruiters and sports media (she helps with merchandizing).

Through the National RTAP Review Board, Michele Smith will have the opportunity to continue as a true Tribal Champion and continue to make a difference for Tribal Transit systems everywhere.




The Wadsworth Bypass was designed to keep heavy traffic away from the school zone for safety concerns. Completed, it will be 2.9 miles paved from SR 427 to the SR 447 Olinghouse intersection. A & K Earthmovers is the awarded Contactor. Construction began November 18, 2024, and is projected to be finished at Fall of 2025.

Notice is hereby given that the Pyramid Lake Paiute Tribe ("Tribe") invites proposals for providing building maintenance services for the Victim Services Program of the Pyramid Lake Paiute Tribe for 2025. The maintenance services are to be provided by a licensed, bonded, and insured contractor. This request is only open to those qualified businesses/individuals who satisfy the requirements stated herein and who are licensed and available to do business in the State of Nevada and on the Pyramid Lake Paiute Indian Reservation.

If you are age 18 by June 30, 2025, and on the approved list of eligible Pyramid Lake Paiute Tribal members per Resolution PL#34-18, then you are eligible to apply for the Minor's Trust. (See Resolution on our website at plpt.nsn.us/enrollment). This is for those enrolled as a Pyramid Lake Paiute Tribal member and living as of April 6, 2018.)

 Minors will have up to six years to complete their forms and claim their economic stimulus payment. The deadline to submit your forms for this 2nd Quarter of 2025 is on the last Monday of June 2025. Applications received by 06/30/25 will be processed and forwarded to the Trust the next business day.

- Tribal members under the age of 18 will have their economic stimulus payment placed in a trust account to be managed by the Trust until they reach 18 years of age.

- Members who will receive their payment from the Minor's Trust can expect distributions within one month after the end of the calendar quarter (March, June, September, or December) after they return the completed and signed application.

- Members who have an account in the Minor's Trust will have six years to claim their economic stimulus payment, from the date of their 18th birthday.

- 1. Funds will be received at least 3 months after quarter deadline. Please plan accordingly.
- 2. All Minors' Applications are processed at the same time turning in a form earlier than the deadline doesn't ensure a faster result.

NOTE: \*\*You may turn in your form earlier, but it will be held until the appropriate Quarter Deadline your birthday falls under.\*\*

3. The whole process goes from receiving and verifying your information with our PLPT Enrollment office, which includes verifying Enrollment numbers, social security numbers and updated addresses. The paperwork is then submitted to the Trust Company, where it is then processed there for at <u>least a month</u>. The Trust Company then submits their completed forms to the Bank, and after verification with the bank, your money will THEN be distributed – this sometimes takes up to 3 MONTHS. Please plan accordingly, and expect that your money will arrive 3 MONTHS after the Quarter Deadline.

4. The Trust company will contact the PLPT office for more information according to their standards – your contact information needs to be legible just in case we need to reach you. If you can't be reached, your form will be held until you contact us.

Direct bus services from Sutcliffe to Nixon for commuters, and bus stops directly from the lake to Reno/Sparks areas.



#### What do I do if I get an Ambulance Bill from the Tribe

As an Enrolled member or legal spouse, of the Pyramid Lake Paiute Tribe, our ambulance does not "balance bill" you for our services.

What does that mean? To provide services to the members the EMS must bill insurance companies to help offset the high cost of ambulance services. So, if you're a member and your insurance does not pay the entire bill, we do not Balance bill you for the remainder instead the Tribe writes off the bill as a loss. *For example*, if your bill is \$1,000.00 and your insurance only pays \$800.00 we write off the balance of \$200.00.

What if I get a bill? If you receive a bill from the Pyramid Lake Fire Rescue/EMS it most likely means one or two things happened. 1) our medics did not get your PLPT enrollment number this is what we use to keep from balance billing our Tribal members. 2) Our medics did not get any or enough insurance information from you to be able to bill the insurance company. We understand that when you are sick or injured these things are not your priority at the time.

I received an Ambulance bill what do I do with it? Most importantly do not throw it away or ignore it, that can cause the bill to go to a collection agency. If this happens we can no longer help you with the bill and, you will be responsible for settling the debt. Don't let this happen.

Instead, when you receive a bill, call the fire department right away at **775-574-8999** and speak with our on-duty supervisors, they will assist you in obtaining the necessary information and contact the billing company and the bill will be taken care of, at no cost to you.

**Can I call or give the bill to the Clinic? No**, the fire department is a separate department of the Tribe so going to the clinic will only slow down getting the bill resolved. Again, call the fire department upon receipt of any EMS bills at **775-574-8999**.

Your Pyramid Lake Fire Rescue/EMS is always available 24/7 to serve our community.
