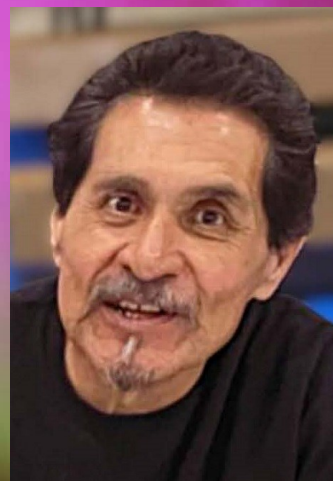

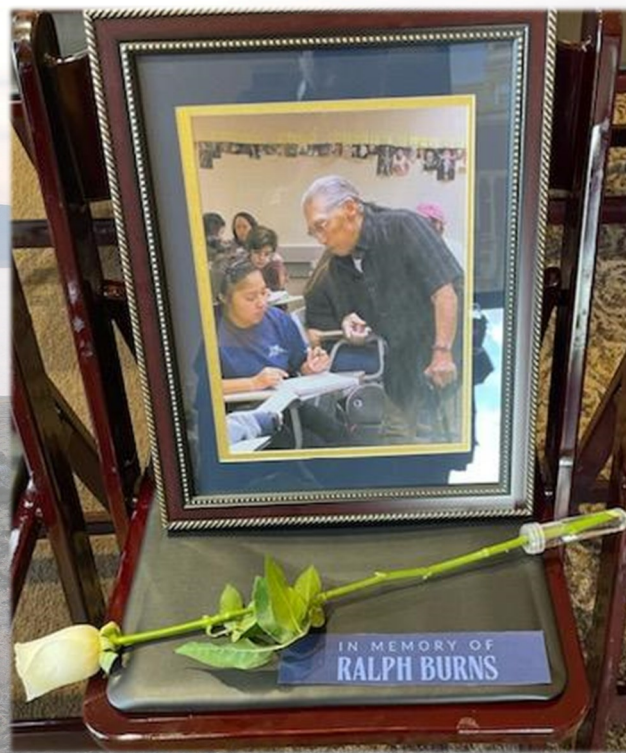

Cobell Indian Trust Settlement



Over 17,000 Individual Indian Money (IIM) account holders passed away before they received money from the trust, and as a result, approximately \$38 million is available to pay eligible heirs.

Payments to heirs could be significant and we do not want people to miss the deadline.

Heirs of deceased holders of IIMs need to act quickly. The deadline to file documentation with the Claims Administrator, Kroll Claims Administration, is **June 30, 2025**. After June 30, claims will no longer be accepted and any funds remaining in the settlement trust will be distributed to the Cobell Scholarship fund.

INDIAN TRUST SETTLEMENT

Are you an Heir of an Individual Indian Money Account Holder?

**\$38 MILLION IS AVAILABLE TO PAY HEIRS.
THE DEADLINE TO FILE A CLAIM IS JUNE 30, 2025.**

What is this about?

A \$3.4 billion dollar settlement was approved in a class action lawsuit, called *Cobell v. Salazar*, that claimed individual Indian land, funds and other assets were mismanaged by the federal government.

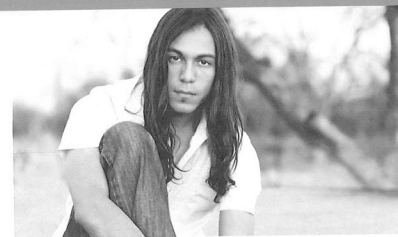
Who is eligible?

You are eligible for a money award if you are an heir of one or more of the over 17,000 Individual Indian Money (IIM) account holders whose *Cobell* settlement awards were not distributed. You must submit a claim form with proof that you are an heir. Claim forms can be submitted online or can be downloaded and mailed to the administrator by June 30, 2025. More details are available on the website.

Here is what you need.

Heir eligibility proof includes any of the following:

- A state or tribal probate order identifying estate heirs; or
- A last will and testament approved by a probate order; or
- A small estate document from an approved state in accordance with small estate procedures; or
- Documentation showing the appointment of an estate Executor, Administrator, or Personal Representative; or
- A federal probate order that directs distribution of trust funds or trust lands.



A copy of a tribal, or state, or federal probate order is needed to establish whether the Settlement Administrator can pay the heir(s) directly for the estate's Settlement award.

If you do not have a tribal or state probate order but a personal representative or executor has been named for the estate, funds can be released to the representative or executor and they will be responsible for distributing the funds according to the wishes of the deceased Class Member.

After the deadline, all remaining funds will be distributed to the Cobell Scholarship Fund, which is managed by Indigenous Education, Inc.

Washoe County Sheriff's—Hasty Team FB Post, May 13, 2025

Yesterday evening, the Washoe County Sheriff's Office received a request for assistance from the Pyramid Lake Police Department for a possible water rescue on Pyramid Lake near Anahoe Island. Two females had been paddleboarding when they had been blown away from shore towards the east by increasingly strong winds and were unable to get back to shore.

Two Hasty Team rescue swimmers and a team Paramedic, along with members of the Sheriff's Specialized Vehicle Unit (SVU) who brought Marine 20, responded to staging at the Pelican Point boat ramp, where they deployed to locate and assist the two stranded paddleboarders.

With assistance from Pyramid Lake PD, who maintained visual contact with the two subjects via binoculars, Marine 20 was able to quickly locate and retrieve the two paddleboarders who had been blown nearly 6 miles off shore by strong winds.

Everyone returned to staging at Pelican Point unharmed and the two females and their paddleboards were returned to their families by Pyramid Lake Police.

With summer boating and watersports season just getting started, just a quick friendly reminder from the Sheriff's Office to always wear an appropriate Personal Flotation Device (PFD) when you are recreating on our local lakes and rivers.



Environmental law backed by Pyramid Lake Paiute Tribe passes Nevada Senate

A bill that passed the Nevada Senate on Tuesday could acknowledge that sovereign tribal nations are on the same level as municipalities in matters of environmental notice. The proposed law, backed by the Pyramid Lake Paiute Tribe, came about in response to an incident that allowed pollution to flow into the lake from upstream for more than a year and a half.

The Pyramid Lake Paiute Tribe is a sovereign nation, but tribal leaders say they feel other municipalities sometimes forget that. Case in point: In 2023, the tribe was left in the dark as millions of gallons of sewage spilled into the Truckee River, making its way downstream to Pyramid Lake.

Senate Bill 276, currently being considered in the legislature, proposes to address future water pollution notifications. In doing so, it acknowledges tribal sovereignty.

The Pyramid Lake Paiute Tribe didn't learn of the 2023 incident until a local TV station reported it. According to News 4 in Sparks, Nevada, construction crews accidentally mixed up sewage and storm drain lines while building the Atrium Apartments. The mistake sent the equivalent of nearly four Olympic swimming pools of sewage into the Truckee River.

Pyramid Lake Paiute Tribe Chairman Steven Wadsworth says the city of Sparks never notified the tribe.

"How do you get away with doing that? Fixing the problem and then still not notifying those down river that there was a problem, there was sewage spilt? As a tribe, it's like a slap in the face."

Sewage lines carry more than just human waste. Chemicals, oils, cleaning products and potentially harmful pathogens may also have made their way to the lake over more than a year.

"You need to inform those that could be affected. You need to have that government-to-government relationship. If your city inspectors didn't do it correctly and they report it to their higher ups, and they of course keep reporting it on up the chain. We're not talking about going up the chain, what about those that are on the same level as you are. And that's the thing, when it came to the same level, you did not report to the tribe."

The proposed law would require any municipality or water

authority that knows of an unauthorized spill into state waters to notify the Nevada Division of Environmental Protection. The division would then notify potentially impacted tribes or local governments.

No law requiring a municipality to inform a tribe of a spill currently exists. Previously, the city's policy left the notification responsibility to the property owner, according to the city of Sparks.

The city has since adjusted its policy.

For the Pyramid Lake Paiute Tribe, the lake's health is tantamount to their health.

"The lake and the river is everything to the tribe. That's because our namesake, Cui-ui-Tuccutta, which translates to fish eater, that is our namesake. That's what we are known as, here at Pyramid Lake. That is just the core of our being, you know."

In an emailed response, the City of Sparks said the "oversight was simply a regrettable human error."

Pyramid Lake Paiute Community Calls for Justice at MMIP Solidarity Walk

Nixon, NV — The Pyramid Lake Paiute Tribe came together in a powerful show of unity, remembrance, and hope during its recent MMIP Solidarity Walk, a community event dedicated to honoring missing and murdered Indigenous Persons (MMIP) and demanding justice for those who can no longer speak for themselves.

The day began with a heartfelt prayer from respected elder Reynelda James, followed by opening remarks from tribal leaders and community members who shared messages of condolence, strength, and solidarity. As families of missing and murdered loved ones stood in solemn remembrance, the walk served as a painful reminder of loss and a testament to the unyielding spirit of the Pyramid Lake Paiute people.

Native Public Media participated in the event with an informational booth on the Federal Communications Commission's new Missing and Endangered Persons (MEP) Alert. The MEP Alert supports Tribal communities in issuing urgent alerts for at-risk lives. Many attendees were unaware of the MEP Alert Code, but all agreed it is a crucial resource in helping Tribal Nations respond more effectively to MMIP cases.

A key moment of the day was the debut of the documentary "Not Forgotten" by a young Indigenous filmmaker. The film shares the stories of Amanda Davis and Anna Scott, both Pyramid Lake Paiute Tribal members who were taken too soon. Amanda and her unborn son, Ezra, were brutally murdered in 2020. Their killer was convicted. Amanda's mother encouraged others to remain strong and never give up hope.

The family of Anna Scott, whose body was found in a burned vehicle in Reno, expressed their deep frustration with law enforcement's handling of the case, jurisdictional confusion, and the media's lack of attention. Her case remains open, but her family remains determined to pursue justice.

The MMIP Solidarity Walk united families, advocates, and organizations in a healing space where stories were shared, resources exchanged, and lives remembered. "This walk is about more than grief," said one participant. "It's about resilience, it's about action, and it's about making sure we never forget our loved ones."





May 14, 2025 Congratulations to the Pesa Sooname Advisory Group on a successful Nevada Tribal Summit on Age- and Dementia-Friendly Care!

This year's summit **"Mind: Exploring Cognitive Health and Mental Well-Being in Native Communities"** brought together tribal leaders, healthcare providers, care partners, and community members to explore cognitive health and dementia through a lens of cultural relevance and community strength. With a focus on risk reduction, care and support, and community-based solutions, the Summit fostered moving, meaningful dialogue and presented actionable strategies to support mental well-being in Native communities.

The 2025 Summit was the first of five annual Summits (2025 - 2029) organized around the "5M's" of age-friendly care: Mind, Mobility, Medication, Multi-complexity, and what Matters most.

89 people representing 12 tribes, from Nevada and beyond, participated in the Summit, with almost universal positive feedback!

If you are age 18 by **June 30, 2025**, and on the approved list of eligible Pyramid Lake Paiute Tribal members per Resolution PL#34-18, then you are eligible to apply for the **Minor's Trust**. (See Resolution on our website at plpt.nsn.us/enrollment). This is for those enrolled as a Pyramid Lake Paiute Tribal member and living as of April 6, 2018.)

- Minors will have up to six years to complete their forms and claim their economic stimulus payment. The deadline to submit your forms for this 2nd Quarter of 2025 is on the last Monday of June 2025. Applications received by 06/30/25 will be processed and forwarded to the Trust the next business day.
- Tribal members under the age of 18 will have their economic stimulus payment placed in a trust account to be managed by the Trust until they reach 18 years of age.
- Members who will receive their payment from the Minor's Trust can expect distributions within one month after the end of the calendar quarter (March, June, September, or December) after they return the completed and signed application.
- Members who have an account in the Minor's Trust will have six years to claim their economic stimulus payment, from the date of their 18th birthday.

1. Funds will be received at least 3 months after quarter deadline. Please plan accordingly.

2. All Minors' Applications are processed at the same time – turning in a form earlier than the deadline doesn't ensure a faster result.

NOTE: **You may turn in your form earlier, but it will be held until the appropriate Quarter Deadline your birthday falls under.**

3. The whole process goes from receiving and verifying your information with our PLPT Enrollment office, which includes verifying Enrollment numbers, social security numbers and updated addresses. The paperwork is then submitted to the Trust Company, where it is then processed there for at least a month. The Trust Company then submits their completed forms to the Bank, and after verification with the bank, your money will THEN be distributed – this sometimes takes up to 3 MONTHS. Please plan accordingly, and expect that your money will arrive 3 MONTHS after the Quarter Deadline.

4. The Trust company will contact the PLPT office for more information according to their standards – your contact information needs to be legible just in case we need to reach you. If you can't be reached, your form will be held until you contact us.

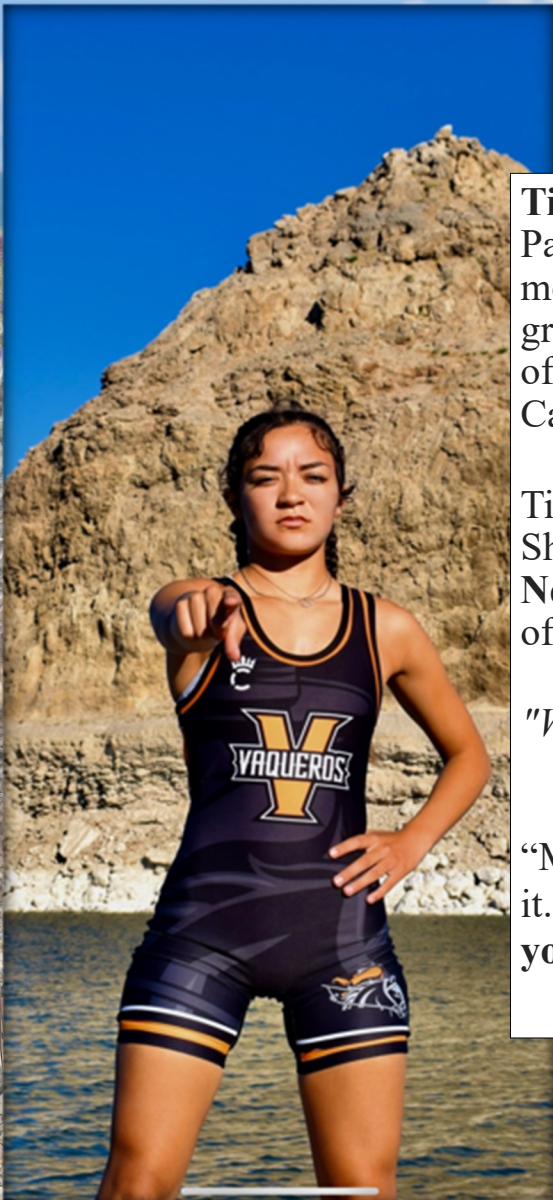
