Free Rabies Vaccination Clinic

Friday, August 8, 2025.

Location and times:

Wadsworth Community Center: 11:30—1:30 pm

Nixon Gym: 2:00 pm—4:30 pm

Sutcliffe Community Center: 4:30 pm—5:30 pm

All dogs and cats should have their first rabies vaccination at 3 months (12 weeks old), followed by a booster shot within the first year. Thereafter, they should be vaccinated every three years. Please bring your pet's most recent vaccination records with you, if possible.

Pet owners are responsible for their pets during the rabies clinic. A cat in a cage, burlap bag or pillowcase is much easier to handle. Dogs should be leashed at all times during the clinic. Animals that cannot be controlled by the owner, or that pose a safety risk, will not be served.




#JUSTICE FOR ANNA MARIE SCOTT

On the early morning hours of February 3, 2022, Anna Marie Scott was shot, her body placed into the trunk of her car, which was then set on fire on I-580 Southbound on Galena Creek Bridge.

She was 23 years old; she was a mother to two young children; she was a daughter, a cousin, a granddaughter, a friend.

The lack of answers in this horrific case continue to haunt her family and her community.



If you are age 18 by **September 30, 2025, and on the approved list of eligible Pyramid Lake Paiute Tribal members per Resolution PL#34-18, then you are eligible to apply for the Minor's Trust.** (See Resolution on our website at plpt.nsn.us/enrollment). This is for those enrolled as a Pyramid Lake Paiute Tribal member and living as of April 6, 2018/ December 6, 2025.)

- Minors will have up to six years to complete their forms and claim their economic stimulus payment. The deadline to submit your forms for this 3rd Quarter of 2025 is on the last Tuesday of September 2025. Applications received by 09/30/25 will be processed and forwarded to the Trust the next business day.
- Tribal members under the age of 18 will have their economic stimulus payment placed in a trust account to be managed by the Trust until they reach 18 years of age.
 - Members who will receive their payment from the Minor's Trust can expect distributions within 4 months after the end of the calendar quarter (March, June, September, or December) after they return the completed and signed application.
- Members who have an account in the Minor's Trust will have six years to claim their economic stimulus payment, from the date of their 18th birthday.

 - June 2, 2025: **For those who have turned 18 after December 6, 2024, your 2024 Christmas Distribution Funds were placed into the trust, so you will have to follow these guidelines to obtain your funds.**

1. Funds will be received at least 4 months after quarter deadline. Please plan accordingly.

2. All Minors' Applications are processed *at the same time* – turning in a form earlier than the deadline doesn't ensure a faster result.

NOTE: **You may turn in your form earlier, but it will be held until the appropriate Quarter Deadline your birthday falls under.**

3. The whole process goes from receiving and verifying your information with our PLPT Enrollment office, which includes verifying Enrollment numbers, social security numbers and updated addresses. The paperwork is then submitted to the Trust Company, where it is then processed. The Trust Company then submits their completed forms to the Bank, and after verification with the bank, your money will THEN be distributed – this sometimes takes up to 4 MONTHS. Please plan accordingly, and expect that your money will arrive 4 MONTHS **after** the Quarter Deadline.

4. The Trust company will contact the PLPT office for more information according to their standards – your contact information needs to be legible just in case we need to reach you. If you can't be reached, your form will be held until you contact us.

Rescue teams brave severe winds to save stranded individuals at Pyramid Lake

RENO, Nev. — On Thursday night, the Washoe County Sheriff's Office Search and Rescue Team was called upon by the Pyramid Lake Police Department to assist in multiple water rescues.

Severe winds had left several individuals, including juveniles

on rafts, kayakers, swimmers, jet skiers, and a disabled boat, stranded and unable to return to shore.

The WCSO SAR deployed Marine 10 and Marine 20, along with Specialized Vehicle Unit operators and Hasty Team rescue swimmers, who navigated high winds and rough waves to bring everyone safely back to land.



New details released in July 4th crash on Pyramid Highway that left one juvenile dead

JULY 9 UPDATE:

Additional details have been released in a fatal crash on Pyramid Highway that happened on July 4th.

Three juveniles were ejected from the car in the crash, which left one juvenile dead at the scene, while two others were hospitalized with serious injuries.

The woman who was driving the car was also hospitalized with minor injuries.

Nevada State Police confirmed in a release that impairment is not suspected in the crash.

ORIGINAL ARTICLE (JULY 4)

A crash Friday night on Pyramid Highway has left a juvenile dead and injured three other people, including a juvenile who suffered life-threatening injuries.

It happened around 7:15 p.m. on Pyramid Highway between Sutcliffe Highway and the Pyramid Lake Store, according to a spokesperson for the Nevada Highway Patrol.

A black GMC Yukon was heading north on Pyramid Highway when it ran off the road to the right. The driver overcorrected to the left, lost control, and the car flipped, NHP says.

There were six people in the car when it crashed, including five juveniles and one adult woman. Multiple people were

ejected, one of whom was a juvenile who was pronounced dead at the scene.

One juvenile was taken to the hospital with life-threatening injuries, and another with moderate injuries, while the adult woman suffered minor injuries.

Two juveniles did not sustain injuries.

Pyramid Highway is closed between Sutcliffe Highway and the Pyramid Lake Store. There is no estimated time for the road to reopen.

People are asked to avoid the area and take alternate routes if possible.
