RESOLUTION OF THE TRIBAL COUNCIL OF THE PYRAMID LAKE PAIUTE TRIBE NIXON, NEVADA

WHEREAS, the Pyramid Lake Paiute Tribe is organized pursuant to the provisions of Section 16 of the Indian Reorganization Act of 1934 (25 U.S.C. § 476), and is Federally recognized by the United States Government through the United States Department of Agriculture to work with the Natural Resources Conservation Service (NRCS); and

WHEREAS, NRCS and its Agricultural Management Assistance (AMA) to repair engineering errors on the Nixon Ditch Irrigation System that supplies water to Tribal Member's agricultural fields; and

WHEREAS, the contract will repair the Nixon Ditch infrastructure to supply water to agricultural lands that Tribal Members use for their income; and

WHEREAS, the management of the infrastructure construction for Nixon Ditch on the Pyramid Lake Reservation would allow the Tribe to provide sufficient and needed irrigation water to the agricultural fields; and


WHEREAS, the Natural Resources Department followed the procurement policy and selected A&K Earthworks to be the contractor on this project.

NOW THEREFORE, BE IT RESOLVED, that the Pyramid Lake Paiute Tribal Council hereby approves, supports, and authorizes the contract with the NRCS and A&K Earthworks to perform tasks to be incorporated in the Natural Resources Conservation Service Equitable Relief Request Contract Number: 769327140A4 Nixon Ditch for the irrigators along Nixon Ditch on the Pyramid Lake Reservation.

BE IT FURTHER RESOLVED, the Tribal Chairman or designee is hereby authorized to negotiate and sign all contracts and awards and other future administrative documents necessary for project implementation.

CERTIFICATION
