RESOLUTION OF THE TRIBAL COUNCIL OF THE PYRAMID LAKE PAIUTE TRIBE NIXON, NEVADA

- WHEREAS,** the Pyramid Lake Paiute Tribe, is organized pursuant to the provisions of Section 16 of the Indian Reorganization Act, (25 U.S.C. 476) and is Federally recognized by the United States Government through the Secretary of the Interior to work with the Environmental Protection Agency; and
- WHEREAS,** the Environmental Protection Agency is soliciting for eligible projects under its Solid Waste Infrastructure for Recycling (SWIFR) to approve all eligible projects for funding considerations and obtain funding for the Solid Waste Management and Infrastructure on Indian Trust lands for the benefit of the Tribe; and
- WHEREAS,** the grant program provides funding for the development of infrastructure for sustainable and efficient recycling program; and
- WHEREAS,** the management of the infrastructure construction for the recycling program on the Pyramid Lake Reservation would allow the Tribe to provide better environmental protection of Tribal lands and reduce impacts of solid waste to Tribal Trust Resources; and
- WHEREAS,** the proposal being submitted is consistent past with planning, development, and implementation efforts towards environmental protection on the Pyramid Lake Indian Reservation for the betterment of the Tribe and its members.

NOW, THEREFORE, BE IT RESOLVED, that the Pyramid Lake Paiute Tribal Council hereby approves, supports, and authorizes the submittal of the proposal to the Environmental Protection Agency, Solid Waste Infrastructure for Recycling (SWIFR) to perform tasks to be incorporated in the Solid Waste Infrastructure for Recycling (SWIFR) Grant Proposal for the Pyramid Lake Reservation.

BE IT FURTHER RESOLVED, that the Tribal Chairman or designee is hereby authorized to negotiate and sign all grant awards and other future administrative documents necessary for project award and implementation.


CERTIFICATION
